#### I. INTRODUCTION

#### A. Purpose of this Request for Proposal:

The New Mexico Developmental Disabilities Planning Council Office of Treatment guardian (NMDDPC) invites private or public entities and individuals (Offerors) familiar with and experienced in court appointed treatment guardian services in New Mexico to submit proposals in accordance with the specifications contained in this Request for Proposal (RFP). The NMDDPC may contract with more than one Offeror for the services described in this RFP. Successful Offeror(s) will provide court appointed treatment guardian services as defined in the Scope of Work and in the sample contract. Offerors may propose to deliver services statewide or within a limited geographical area. Offerors may propose to serve individuals with various incapacities or may propose to serve individuals with a specific incapacity.

#### B. Summary Scope of Work:

The Contractor will administer a program that promotes effective and responsible mental health treatment guardianships and facilitate publically funded mental health treatment guardianship appointments in the general Albuquerque area and other areas as determined jointly by the Agency and the Contractor. Under this contract, the Contractor's primary responsibility will be to train mental health treatment guardians to be appointed by the courts, in either an inpatient or outpatient basis. The treatment guardian paid under this contract may be appointed as the primary decision-maker while a family member or other care giver is appointed by the Court as an alternate treatment guardian (decision-maker). When required, the Contractor will try to make arrangements for interpreters and for translation (Spanish and other languages). The Contractor will also be responsible for paying mental health treatment guardians (who are not family members or volunteers) for each appointment, as specified in this agreement.

#### C. Scope of Procurement

The scope of the procurement shall encompass the requirements in the contract (Appendix E of this RFP). The proposed contract will be effective the date of signature of the New Mexico Department of Finance and Administration (DFA).

The initial term for the contract is expected to be July 1, 2013 to June 30, 2014, with renegotiation of the contractual terms for the purpose of continuing the services described in this RFP and adding additional services and funding as needed and available. The NMDDPC reserves the option of renewing the initial contract(s) on an annual basis for three (3) additional years or any portion thereof for the purpose of providing continued services based on contractor performance and availability of funding. In no case will the contract, including all renewals thereof, exceed a total of four (4) years in duration.

The total amount available for contracting these services in FY2014 will be subject to appropriation. Funding will be derived, as available, from NMDDPC.

#### D. Offeror Qualifications/Conflict of Interest

This RFP is open to any Offeror capable of performing the work described in Section IV Mandatory Specifications, subject to the following stipulations:

- 1. Pursuant to the Governmental Conduct Act, NMSA 1978, Sections 10-16 et.seq., an Offeror will have no direct or indirect interest that conflicts with the performance of services covered under this RFP;
- 2. Pursuant to NMSA 1978 Sections 13-19-191, 30-41-1through 30-41-3, an Offeror may not provide or offer bribes, gratuities or kickbacks to applicable state personnel;
- 3. An Offeror shall ensure that no elected or appointed officer or other employee of the State of New Mexico shall benefit financially or materially from the successful award of the contract to the Offeror and that no such individual shall be admitted to any share or part of the contract or to any benefit that may arise there from;
- 4. An Offeror shall ensure that there is no conflict, either direct or indirect, with its agency or organization and its fiduciaries and/or employees, with the performance of services covered under this RFP; and
- 5. The burden is on the Offeror to present sufficient assurance to the NMDDPC that the award of the contract to the Offeror shall not create a conflict of interest.

#### **Definition of Terminology**

This section contains definitions and abbreviations that are used throughout this procurement document.

"C.O.B" or "Close of Business" means 4:00PM Mountain Daylight Time.

"Contract" means a written agreement for the procurement of items of tangible personal property or services. This includes purchase, rental, lease and licensing agreements.

"Contract Manager" means the individual designated by the NMDDPC to monitor and manage all aspects of the contract resulting from this RFP, including directing the work of the Contractor. This person is the NMDDPC Program Manager.

"Contractor" means a successful Offeror, who enters into a binding contract, who will perform the task(s) outlined in the scope of procurement detailed in this request for proposals.

"NMDDPC" means New Mexico Developmental Disabilities Planning Council.

**"Deliverable"** means any measurable, tangible, verifiable outcome, result or item that must be produced to complete a project or part of a project.

**"Determination"** means the written documentation of a decision by the Procurement Manager, including findings of fact supporting a decision. A determination becomes part of the procurement file.

**"DFA/CRB"** means the Contract Review Bureau of the Department of Finance and Administration for the State of New Mexico.

**"Evaluation Committee"** means a body appointed by the NMDDPC to perform the evaluation of Offeror proposals.

**"Evaluation Committee Report"** means a report prepared by the Procurement Manager and the Evaluation Committee for submission to the NMDDPC for contract award that contains all written determinations resulting from the conduct of a procurement requiring the evaluation of competitive sealed proposals.

"Factor" means a section of the RFP that requires a response.

**"Finalist"** is defined as an Offeror who meets all the mandatory specifications of this Request for Proposal and whose score on evaluation factors is sufficiently high to merit further consideration by the Evaluation Committee.

**"Mandatory"** means that the terms "must", "shall", "will", "is required", or "are required" identify a mandatory item or factor (as opposed to "desirable"). Failure to meet a mandatory item or factor will result in the rejection of the Offeror's proposal.

"Offeror" means an agency or organization "offering" their services by submitting a proposal.

**"Performance Measure"** means a unit of evaluation specified by the state that enables performance to be determined.

**"Procurement Code"** means the law that governs the process of procurement for the State of New Mexico.

"Procurement Code Regulations" means General Services (GSD) Rule 1NMAC 5.2.

**"Procurement Manager**" means the person or designee authorized by the NMDDPC to manage or administer a procurement, requiring evaluation of competitive seals proposals. The only designated person from whom the Offeror may receive RFP information during the process of submission and selection of a proposal.

**"Request for Proposals"** means all documents, including those attached or incorporated by the reference, used for soliciting proposals.

"RFP" means Request for Proposals.

**"Responsible Offeror"** means an Offeror who submits a responsive proposal and who had furnished, when required, information and data to prove that his financial resources, production or services facilities, personnel, service reputation and experience are adequate to make satisfactory delivery of the services or items of tangible personal property described in the proposal.

**"Responsive Offer" or "Responsive Proposal"** means an offer or proposal that conforms in all material respects to the requirements set forth in the Request for Proposals. Material aspects of a Request for Proposals include, but are not limited to price, quality, quantity or delivery requirements.

**"State Purchasing Division" or "SPD"** means the purchasing division of the General Services for the State of New Mexico.

**"Subcontractor"** means a person or business which has a contract (as an "independent contractor" and not an employee) with a contractor to provide some portion of the treatment guardian services which the contractor has agreed to perform.

## II. CONDITIONS GOVERNING THE PROCURMENT

This section of the RFP contains the schedule for the procurement and describes the major procurement events as well as the conditions governing the procurement.

#### A. Sequence of Events

The Procurement Manager will make every effort to adhere to the following schedule. The following schedule will be followed as closely as possible in the procurement of the services described in this RFP. The NMDDPC reserves the right to revise this schedule without the need for formal amendment. Offerors will be notified, in advance, in the event a schedule revision is required.

**B.** The following paragraphs describe the activities listed in the sequence of events shown in Section II, Paragraph A.

## 1. Issue of RFP

This RFP is being issued by NMDDPC. Potential Offerors may obtain a copy of the RFP from the Procurement Manager.

## 2. Deadline to Submit Acknowledgement of Receipt Form

Potential Offerors must hand deliver or return by facsimile, or by registered or certified mail to the Procurement Manager the "Acknowledgement of Receipt of Request for Proposals Form" that accompanies this document (Appendix A) in order to have their organization placed on the procurement distribution list. This form must be signed by an authorized representative of the organization, dated and returned to the Procurement Manager by close of business on date referenced in the "Sequence of Events" timeline.

## 3. <u>Pre-Proposal Conference</u>

A pre-proposal conference will be held to allow Potential Offerors to ask questions and clarify issues concerning this RFP. It will be held April 19, 2013, at 3:00 pm at the Center for Self Advocacy located at 2340 Menaul NE, Albuquerque, NM.

Potential Offerors are encouraged to submit written questions in advance of the conference to the Procurement Manager. The identity of the organizations submitting the question(s) will not be revealed. Additional written question may be submitted at the conference. A public log will be kept of the names of the potential Offerors that attended the pre-proposal conference.

Attendance at the pre-proposal conference is <u>not</u> a prerequisite for submission of a proposal, but is strongly encouraged for all Potential Offerors.

## 4. Deadline to Submit Additional Written Questions

Potential Offerors may submit additional written questions as to the intent or clarity of this RFP until the date referenced in the "Sequence of Events." All written questions must be addressed to the Procurement Manager. Questions shall be clearly labeled and shall cite the Sections in the RFP or other document which form the basis of the question.

## 5. <u>Response to Written Questions/RFP Amendments</u>

Written responses to written questions and any RFP amendments will be distributed on or about the date referenced in "Sequence of Events" to all potential Offerors whose organization name appears on the procurement distribution list. NMDDPC shall make every effort to meet this timeline or provide answers as close to the deadline as possible.

## 6. <u>Submission of Proposal</u>

ALL OFFEROR PROPOSALS MUST BE RECEIVED FOR REVIEW AND EVALUATION BY THE PROCUREMENT MANAGER NO LATER THAN 4:00 PM MOUNTAIN DAYLIGHT TIME ON MAY 3, 2013. Proposals received after this deadline will not be accepted. The date and time of receipt will be recorded on each submission. Proposals must be addressed and delivered to the attention of the Procurement Manager at the address listed in Section I, Letter E. Proposals must be **sealed and labeled** on the outside of the package to clearly indicate that they are in response to the NMDDPC Request for Proposals. Proposals submitted by facsimile or other electronic media will not be accepted. A failure to follow these directions may result in the immediate disqualification of the submitted proposal.

A public log will be kept of the names of all Offeror organizations that submit proposals. Pursuant to Section 13.1.116 NMSA 1978, the contents of any proposal shall not be disclosed to competing Offerors or to the public prior to contract award.

#### 7. <u>Proposal Evaluation</u>

The evaluation of proposals will be performed by an Evaluation Committee appointed by the NMDDPC Program Committee. This process will take place between dates referenced in "Sequence of Events" During this time, the Procurement Manager may initiate discussions with Offerors who submit responsive or potentially responsive proposals for the purpose of clarifying aspects of the proposals, although proposals may be accepted and evaluated without such discussion. Discussions SHALL NOT be initiated by the Offerors.

#### 8. Selection of Finalists

The Evaluation Committee will select the finalist Offerors, and the Procurement Manager will notify the finalist Offerors, on the date referenced in "Sequence of Events" timeline. Only finalists will be invited to participate in the subsequent steps of procurement.

#### 9. Best and Final Offerors from Finalists

Finalist Offerors may be asked to submit revisions to their proposals for the purpose of obtaining best and final offers by the date referenced in the "Sequence of Events" timeline. Best and final offers may be clarified, if solicited by the Procurement Manager and amended by agreement of Offeror and Procurement Manager.

#### 10. Award and Finalize Contract

The contract shall be awarded to the Offeror whose proposal is most advantageous taking into consideration the evaluation factors set forth in the RFP. The most advantageous proposal may or may not have received the most points.

The contract will be finalized with the most advantageous Offeror on the date referenced on the "Sequence of Events" timeline. In the event that mutually agreeable terms cannot be reached within the time specified, the NMDDPC reserves the right to finalize a contract with the next most advantageous Offeror, without undertaking a new procurement process or cancelling the award.

## 11. Effective Date of Contract Award

The award is subject to appropriate State approvals. Following the review of the Evaluation Committee Report and the recommendation of NMDDPC's management and approval, DFA will approve the contract on or before the date referenced in the "Sequence of Events" timeline. This date is subject to change at the discretion of the NMDDPC.

## 12. Protest Deadline

Any protest by an Offeror must be timely and in conformance with Section 13-1-172 NMSA 1978 and applicable procurement regulations. The fifteen working (15) day protest period for responsive Offerors shall begin on the day following the contract award and will end at close of business on date referenced in the "Sequence of Events" timeline. Protests must be written and must include the name and address of the protestor and the Request for Proposals number. It must also contain a statement of grounds for protest, including appropriate supporting exhibits and it must specify the ruling requested from the Procurement Manager. Protests received after the deadline or not in conformance with Section 13-1-172 NMSA 1978 and applicable procurement regulations will not be accepted.

## C. <u>General Requirements</u>

This procurement will be conducted in accordance with the State Purchasing Agent's procurement regulations, 1.4.1 NMAC, et. seq.

## 1. Acceptance of Conditions Governing the Procurement

Offerors must indicate their acceptance of the Conditions Governing the Procurement section in the Letter of Transmittal. Submission of a proposal constitutes acceptance of the Evaluation Factors contained in Section V of this RFP.

## 2. Incurring Cost

Any cost incurred by the Offeror in preparation, transmittal, presentation of any proposal or material submitted in response to this RFP shall be borne solely by the Offeror.

#### 3. Prime Contractor Responsibility

Any contract that may result from this RFP shall specify that the prime contractor is solely responsible for fulfillment of the contract with NMDDPC. NMDDPC will make contract payments to only the prime contractor.

#### 4. <u>Subcontractors</u>

The Contractor shall not subcontract any portion of the services to be performed under this Agreement without the prior written approval of the Agency. No such subcontract shall relieve the primary Contractor from its obligations and liabilities under this Agreement, nor shall any subcontract obligate direct payment from the Procuring Agency.

#### 5. <u>Amended Proposals</u>

An Offeror may submit an amended proposal, before the deadline for receipt of proposals. Such amended proposal must be complete replacements for a previously submitted proposal and must be clearly identified as such in the transmittal letter. The NMDDPC personnel will not merge, collate or assemble proposal materials.

#### 6. Offeror's Rights to Withdraw Proposal

Offerors will be allowed to withdraw their proposals at any time prior to the deadline for receipt of proposals. The offeror must submit a written withdrawal request signed by the Offeror's duly authorized representative addressed to the Procurement Manager.

The approval or denial of withdrawal requests received after the deadline for receipt of the proposals is governed by the applicable procurement regulations.

## 7. <u>Proposal Offer Firm</u>

Responses to this RFP, including proposal prices, will be considered firm for ninety (90) days after the due date for receipt of proposals or sixty (60) days after receipt of a best and final offer, if one is submitted.

#### 8. Disclosure of Proposal Contents

The proposals will be kept confidential until a contract is awarded. At that time, all proposals and documents pertaining to the proposals will be open to the public, except for the material that is proprietary or confidential. The Procurement Manager will not disclose or make public any pages of a proposal on which the Offeror has stamped or imprinted "proprietary" or "Confidential" subject to the following requirements.

Proprietary or confidential data shall be readily separable from the proposal in order to facilitate eventual public inspection of the non-confidential portion of the proposal. Confidential data is normally restricted to confidential financial information concerning the Offeror's organization and data that qualifies as a trade secret in accordance with the Uniform Trade Secrets Act [57-3A-1 to 57-3A-7 NMSA 1978]. The price of products offered or the cost of services proposed shall not be designated as proprietary or confidential information.

If a request is received for disclosure of data for which an Offeror has made a written request for confidentiality, the NMDDPC's Procurement Manager shall examine the Offeror's request and make a written determination that specifies which portions of the proposal should be disclosed. Unless the Offeror takes legal action to prevent the disclosure, the proposal will be so disclosed. The proposal shall be open to public inspection, subject to any continuing prohibition on the disclosure of confidential data.

#### 9. No Obligation

This procurement in no manner obligates the State of New Mexico or any of its agencies to the eventual rental, lease, purchase, etc. of any equipment, software or services until a valid written contract is awarded and approved by the appropriate authorities.

#### 10. Termination

This RFP may be canceled at any time and any and all proposals may be rejected in whole or in part when the NMDDPC determines such action to be in the best interest of the State of New Mexico.

#### 11. Sufficient Appropriation

Any contract awarded as a result of this RFP process may be terminated if sufficient appropriations or authorizations do not exist. Such termination will be effected by sending written notice to the contractor. The NMDDPC's decision as to whether sufficient appropriations and authorizations are available will be accepted by the contractor as final.

#### 12. Legal Review

The NMDDPC requires that all Offerors agree to be bound by the General Requirements contained in this RFP. Any Offeror concerns must be promptly brought to the attention of the Procurement Manager.

#### 13. Governing Law

This procurement and any agreement with Offerors that may result shall be governed by the laws of the State of New Mexico.

#### 14. Basis for Proposal

Only information supplied by the NMDDPC in writing through the Procurement Manager, or in this RFP and subsequent RFP amendments should be used as the basis for the preparation of Offeror proposals.

## 15. Contract Terms and Conditions

The contract between the NMDDPC and a contractor will follow the format specified by the NMDDPC and contain the terms and conditions set forth in Appendix E "Sample Contract". However, the NMDDPC reserves the right to negotiate with the successful Offeror provisions in addition to those contained in this RFP. The contents of this RFP, as revised and/or

supplemented and the successful Offeror's proposal will be incorporated into and become part of the contract.

Should an Offeror object to any of the NMDDPC terms and conditions, as contained in this Section or in Appendix E, that Offeror must propose specific alternative language in writing. The NMDDPC may or may not accept the alternative language. Offerors agree that requested language must be agreed to in writing by the NMDDPC to be included in the contract. If any requested alternative language submitted is not so accepted by the NMDDPC, the attached sample contract with appropriately accepted amendments shall become the contract between the parties. General references to the Offeror's terms and conditions or attempts at complete substitutions are not acceptable to the NMDDPC and will result in disqualification of the Offeror's proposal.

#### 16. Offeror's Terms and Conditions

Offerors must submit with the proposal a complete set in writing of any additional terms and conditions, which they expect to have included in a contract negotiated with the NMDDPC.

#### 17. Contract Deviations

Any additional terms and conditions that may be the subject of negotiation will be discussed only between the NMDDPC and the selected Offeror and shall not be deemed an opportunity to amend the Offeror's proposal.

#### 18. Offeror Qualifications

The Evaluation Committee may make such investigations as necessary to determine the ability of the Offeror to adhere to the requirements specified within this RFP. The Evaluation Committee will reject the proposal of any Offeror who is not a responsible Offeror or is an Offeror that fails to submit a responsive offer as defined in NMSA 1978 §§ 13-1-83 and 13-1-85.

#### 19. Right to Waive Minor Irregularities

The Evaluation Committee reserves the right to waive minor irregularities. The Evaluation Committee also reserves the right to waive mandatory requirements provided that all of the otherwise-responsive proposals failed to meet the same mandatory requirements and/or doing so does not otherwise materially affect the procurement. This right is at the sole discretion of the Evaluation Committee.

#### 20. Change in Contractor Representatives

The NMDDPC reserves the right to request a change in contractor representatives, if the assigned representatives are not, in the opinion of the NMDDPC, meeting its needs adequately.

#### 21. <u>Notice</u>

The Procurement Code, NMSA 1978 §§ 13-1-28 through 13-1-99, imposes civil and misdemeanor criminal penalties for its violation. In addition, the New Mexico criminal statutes impose felony penalties for bribes, gratuities and kick-backs.

#### 22. Right to Publish

Throughout the duration of this procurement process and contract term, potential Offerors and contractors must secure from the NMDDPC written approval, prior to the release of any information that pertains to the potential work or activities covered by this procurement or the subsequent contract. Failure to adhere to this requirement may result in disqualification of the Offeror's proposal or termination of the contract.

#### 23. Ownership of Proposals

All documents submitted in response to this RFP will become the property of the NMDDPC and the State of New Mexico.

#### 24. Confidentiality

Any confidential information provided to or developed by the contractor in the performance of the contract resulting from the RFP shall be kept confidential and shall not be made available to any individual or organization by the contractor without the prior written approval of the NMDDPC.

The Contractor(s) agrees to protect the confidentiality of all confidential information and not to publish or disclose such information to any third party without the NMDDPC's written permission.

#### 25. Electronic Mail Address Required

A large part of the communication regarding this procurement will be conducted by electronic mail (e-mail). Offeror must have a valid e-mail address to receive this correspondence.

#### 26. Use of Electronic Versions of this RFP

This RFP is being made available by electronic means. If accepted by such means, the Offeror acknowledges and accepts full responsibility to insure that no changes are made to the RFP. In the event of conflict between a version of the RFP in the Offeror's possession and the version maintained by NMDDPC, the version maintained by NMDDPC shall govern.

#### 27. <u>New Mexico Employees Health Coverage</u>

The Offeror must agree with the terms of the New Mexico Employees Health Coverage Form (Appendix G) and submit a signed form with the submittal of their proposal.

#### 28. <u>New Mexico Business Preference</u>

As a desirable specification of this RFP, Offerors will be awarded points if their business is authorized to do business in New Mexico as defined in Section 13-1-22 NMSA 1978. To be awarded the points, Offerors must include a copy of their preference certificate. Five percent of total evaluation points will be awarded as part of the Additional Factors.

#### 29. New Mexico Resident Veteran Preference

As a desirable specification of this RFP, Offerors will be awarded points if they are a resident veteran business heir business is authorized to do business in New Mexico as defined in Sections 13-1-21 and 13-1-22 NMSA 1978. To be awarded the points, Offerors must include a copy of their preference certificate and a completed Resident Veterans Preference Certification (Appendix J). Ten percent of total evaluation points will be awarded as part of the Additional Factors.

The Resident Veteran's preference is separate from the Resident Business preference, and is not cumulative with the resident business preference. However, veteran businesses will still receive the in state preference once the veteran's preference cap is exceeded.

#### 30. <u>Campaign Contribution Disclosure Form</u>

Offeror must complete and sign the Appendix H, Campaign Contribution Disclosure Form whether any applicable contribution has been made or not. This form must be submitted with each proposal whether an applicable contribution has been made or not.

#### 31. Suspension and Debarment Form

The Offeror must complete the certification form in Appendix I to certify compliance with Federal regulations relating to suspension and debarment.

#### 32. Lobbying

No Federal appropriated funds can be paid or will be paid, by or on behalf of the CONTRACTOR, or any person for influencing or attempting to influence an officer or employee of any agency, a Member of Congress, an officer or employee of Congress, or an employee of a Member of Congress in connection with the awarding of any Federal contract, or the making of any Federal grant, the making of any federal loan, the entering into of any cooperative agreement, or modification of any Federal contract, grant, loan or cooperative agreement. If any funds other than deferral appropriated funds have been paid or will be paid to any person influencing or attempting to influence an officer or employee of any agency, a Member of Congress, an officer or employee of Congress, or an employee of a Member of Congress in connection of this Federal contract, grant, loan or cooperative agreement, the CONTRACTOR shall complete and submit "Disclosure Report Standard Form LLL, Form to Lobbying" [http://www.whitehouse.gov/sites/default/files/omb/grants/sflllin.pdf] in accordance with its instructions.

#### **III. RESPONSE FORMAT AND ORGANIZATION**

Failure to conform to format organization may lead to disqualification of any submitted proposal.

#### A. <u>Number of Responses</u>

Offerors shall submit only one (1) proposal.

#### B. <u>Number of Copies</u>

Offerors must submit one (1) original hardcopy proposal plus five (5) complete and identical photocopies for a total of six (6) copies. The original proposal must contain original signatures

and be marked "original." The hardcopy submission must also include a scanned electronic copy of the complete proposal. The electronic submission may be on a disk enclosed in a protective casing or on a flash-drive. Proposals must be submitted to the location specified in Section I, Letter E on or before the closing date and time for receipt of proposals. The Offeror shall not distribute the proposal to any entity not specified in this RFP.

#### C. <u>Proposal Format</u>

All proposals must be typewritten on standard 8  $\frac{1}{2}$ " x 11" paper (larger paper is permissible for charts, spreadsheets, etc.), paginated and placed within secure binders with tabs delineating each section, using the structure noted in Section III, Letter D. The pages should have a one inch margin and font size should be no smaller than Times New Roman 12. The outside of each binder must identify the Offeror and specify that the offer is in response to the PROPOSAL NAME AND RFP#. A failure to follow these instructions may result in the immediate disqualification of the submitted proposal.

#### D. Proposal Organization

The Proposal must be organized, tabbed, paginated and labeled/indexed in the Table of Contents in the following format and must contain, at a minimum, all listed items in the sequence indicated. - New Mexico Veteran Business Preference (Section II, Letter C, Number 29)
- Response to NMDDPC Terms and Conditions (Section III, Letter J)
- Other Supporting Documentation

All forms provided in the RFP must be thoroughly completed and included in the appropriate section of the proposal. The Section and Letter references next to each item listed above, point Offerors to where forms and information on the related topic area can be found in this RFP.

Any proposal that does not adhere to these requirements may be deemed non-responsive and could be rejected on that basis alone.

The Proposal Summary may be included by Offerors to provide the Evaluation Committee with an overview of the technical and business features of the proposal. However, this material will not be used in the evaluation process, unless specifically referenced within the Response to Mandatory Specifications.

Offerors may attach other materials that they feel may improve the quality of their responses. However, these materials should be included as items in a separate appendix, under the heading "Other Supporting Documentation." Each item in this section should be noted in the table of contents with corresponding pagination; each item appearing in this section should be preceded by a brief descriptive narrative.

## E. Letter of Transmittal

Each proposal **MUST** be accompanied by a Letter of Transmittal. The Letter of Transmittal **MUST** include:

- a. Identity of the submitting organization;
- b. The name, title, telephone, fax numbers and email address of the person authorized by the organization to contractually obligate the organization;
- c. The name, title, telephone, fax numbers and email address of the person authorized to negotiate the contract on behalf of the organization;
- d. The names, titles, telephone, fax numbers and email addresses of persons to be contacted for clarification;
- e. Explicitly indicate acceptance of the Conditions Governing and Procurement stated in Section II, Letter C, Number 1;

## F. Cover Sheet Form

## H. Proposal Summary

The proposal summary must be five (5) pages or less. It shall provide the Evaluation Committee with an overview of the technical and business features of the proposal. This material will not be used in the evaluation process but may be used in public notifications regarding the successful Offeror's selection.

#### I. <u>Response to Mandatory Specifications</u>

The mandatory specifications may be found in Section IV of the RFP. This section contains information required in the submission of proposals, Offerors **MUST** respond in the form of a thorough narrative to **EACH** numbered requirement in the order in which they appear in this section. The Offeror **MUST** identify the factor number being answered followed by its response to that question and include as part of the factor response any requested forms and documentation.

#### J. Response to NMDDPC's Terms and Conditions

The Offeror shall explicitly indicate acceptance of the General Requirements and the Contract Terms and Conditions set forth in Sample Contract as provided in Section II, Letter C, Numbers 15-17. Should the Offeror object to any of NMDDPC's terms and conditions, as contained in Appendix E; the Offeror must propose specific alternate language. The Offeror must provide a brief discussion of the purpose and impact, if any, of each proposed change followed by the specific proposed alternate wording.

#### K. Offeror's Additional Terms and Conditions

Offerors must submit with the proposal a complete set in writing of any additional terms and conditions they request to have included in a contract negotiated with the NMDDPC or explicitly state that they have no additional terms.

#### IV. MANDATORY SPECIFICATIONS

The NMDDPC will provide a contract manager to work with and coordinate with the contractor for the term of the contract.

All Offerors are required to respond to each of the numbered mandatory requirements in Section C below in narrative form. The proposal should be as concise as possible, but must include specifics that address EACH of the requirements, outcomes, activities and timelines detailed in this RFP Section. - 3. Include names, job titles, job descriptions and qualifications of all treatment guardian coordinators who will be responsible for completing work related to treatment guardian services outlined in this RFP.
- 4. Include copies of resumes and appropriate professional certifications.

- 5. - 5. Responsive proposal will be evaluated based on the responses to the Factors set forth in Section IV, Letter C, which have been assigned maximum point values, respectively. These point values are summarized below in Section V, Letter B.

The Taxation and Revenue Department (TRD) issuies a three (3) year certificate to each qualified business. Businesses are required to reapply to TRD every three (3) years to renew their certificate.
- 10. New Mexico Resident Veteran Preference: As a desirable specification of this RFP, Offerors will be awarded points in accordance with Sections 13-1-21 and 13-1-22 NMSA 1978 as follows:

- a. Resident veterans businesses with annual revenues of \$1M or less are to receive a 10% preference on their bids and proposals.
- b. Resident veterans businesses with annual revenues of more than \$1M but less than \$5M are to received an 8% preference on their bids and proposals.
- c. Resident veterans businesses with annual revenues of more than \$5M are to receive a 7% preference on their bids and proposals.

Offerer must complete and submit attached "Resident Veterans Preference Certification" (Appendix J) with its proposal.

The Taxations and Revenue Department (TRD) will be issuing a three (3) year certificate to each qualified business. Businesses are required to reapply to TRD every three (3) years to renew their certificate. Points will be awarded based on Offerors ability to provide a copy of a current Resident Business Certificate or Resident Veterans Certificate. The Resident Veteran's preference is separate from the Resident Business preference, and is not cumulative with the resident business preference. However, veteran businesses will still receive the in state preference once the veteran's preference cap is exceeded.

## IT IS AGREED BETWEEN THE PARTIES:

- 1. **Scope of Work.** The Contractor shall provide the following services:
  - A. The Contractor will administer a program that promotes effective and responsible mental health treatment guardianships and facilitate publically funded mental health treatment guardianship appointments in the general Albuquerque area and other areas as determined jointly by the Agency and the Contractor. Under this contract, the Contractor's primary responsibility will be to train mental health treatment guardians to be appointed by the courts, in either an inpatient or outpatient basis. The treatment guardian paid under this contract may be appointed as the primary decision-maker while a family member or other care giver is appointed by the Court as an alternate treatment guardian (decision-maker). When required, the Contractor will try to make arrangements for interpreters and for translation (Spanish and other languages). The Contractor will also be responsible for paying mental health treatment guardians (who are not family members or volunteers) for each appointment, as specified in this agreement.

The Contractor may be requested to participate in Pilot/Demonstration Projects involving mental health treatment guardians, including testing a variety of new practices in seeking improvements in services.

B. Conduct outreach activities, recruitment campaigns for Treatment Guardians, and provide education/training sessions and refresher training for anyone interested (e.g. Courts, mental health facilities, attorneys, family members, friends, professionals, students, others). Develop coordination with colleges/universities (e.g. psychology, health, law, social work, others).

Serve as an educational resource for local organizations on issues related to the role and duties of treatment guardians, the law and ethical standards governing treatment guardians, and the process of identifying and acquiring needed services for adults with mental illness and dual diagnoses. The contractor may also serve as a resource to family members and other care givers, including those appointed by a Court as a treatment guardian.

Update as needed the "Training Manual for Treatment Guardianship" and the "Handbook for Psychiatric Treatment Guardians in New Mexico", supplying copies to the Agency. Create a brochure related to the delivery of treatment guardianship services in New Mexico. The Agency will pay for development of this brochure, not to exceed \$2,500.00, and will pay for printing.

- C. Distribute the mental health treatment guardian educational/training material to judges, newly appointed treatment guardians, mental health personnel, volunteers, and anyone else interested re: mental health treatment guardians.
- D. The expectations for Treatment Guardians include:
  - making mental health care decisions on behalf of the client, including:
    - the client's "best interest" and least drastic means for accomplishing the treatment objective.
    - consulting with the client and considering the client's expressed opinions, and consider client's previous decisions when had capacity.
    - consulting with the physician or other professional proposing treatment, the client's attorney, interested friends, relatives, or other agents or guardians to the extent reasonably practicable in making a decision.
  - communicating all pertinent information to the protected person, unless reasonably certain that substantial harm will result. Also communicating with family members or other care givers when doing so would benefit the client and reasonably certain that substantial harm will not result.
  - participating in the development of the Treatment Plan and follow-up re: compliance, needed changes, etc.
  - participating in the development of the Discharge Plan and involve the family as appropriate.
  - may seek an Enforcement Order from the Court for clients who are not a resident of a medical facility and for whom a treatment guardian has been appointed, who refuses to comply with the decision of the treatment guardian. Such an order may authorize a peace officer to take the person into custody and to transport the client to an evaluation facility and may authorize the facility to forcibly administer treatment.
- E. Monitor and conduct on-going oversight of Treatment Guardians paid under this contract. Include checklists for the treatment guardians, e.g.:
  - ✓ Where is the client living?
  - ✓ Did you talk to client this month via telephone or in person? Include dates and times.
  - $\checkmark$  Amount of time spent with each client.
  - ✓ Where did you meet with client? Jail, hospital, his home?
  - ✓ Do you believe that the client is capable of making his/her own medical decisions? What makes you believe this? Have you discussed your belief with the doctor? Have you or will you report this to the Court?
  - $\checkmark$  What were factors that prevented you from communicating with the client, if any?

Also provide a process for clients, family members, caregivers, services providers, and others able to report problems, and for clients to be able to contact their attorney.

- F. Provide a Monthly Report to the Agency with a complete list of all current Treatment Guardians and the names of each client/ward that is being served by the individual treatment guardian. (This information may be used to cross reference the Agency's data base on all clients currently being served as well as who are the assigned treatment guardians.) A copy of the Court Order verifying appointment should accompany each individual treatment guardian's list of clients. No information of the Court Order should be blacked out. The Monthly Report must also include:
  - where the client is living.
  - whether the client was contacted via telephone or in person (including where), and what were factors that prevented you from communicating with the client, if any
  - whether the client is now capable of making their own medical and other decisions? Why you the treatment guardian believes this? Whether this has been discussed with the doctor? Whether this has been or will be reported to the Court.
  - any grievances/complaints received, and any information related to possible conflicts of interest, abuse of authority.
- G. Treatment guardians may only carry a caseload of 30 clients at one time, except that New Mexico Behavioral Health Institute treatment guardians may carry a caseload of 35 clients at one time. Time is measured from the date of the treatment guardian's court appointment until that appointment expires.
- H. The Contractor shall implement the Caregiver's Criminal History Screening Act as to every treatment guardian, and shall disclose any criminal convictions of staff and of any lawsuits the Contractor has been involved in within the past five (5) years and the status of the lawsuits. Payment for background checks and submission of fingerprint cards and proper documentation to the Department of Health is the contractor's sole responsibility. A Xerox copy of each treatment guardian's fingerprint cards along with the letter of clearance (of no disqualifying convictions) must be sent to the Agency before payment will be made for new treatment guardians.
- I. Provide a quarterly report to the Agency concerning the status of activities described above, including problems, unusual circumstances and the need for additional funding for treatment guardianship before the expiration of the current contract. The Contractor shall submit a quarterly report that includes the following data for each month:
  - (1) The number of clients (unduplicated count) in each location of service
  - (2) The caseload of each treatment guardianship coordinator, including the number of clients in regular contact, and the number no longer contacted.
  - (3) The total number of internal complaints/grievances, broken down into resolved and unresolved
  - (4) The number and percent of the total grievances for each month that were resolved, and the number of days required to resolve each grievance
  - (5) The number and percent of the total grievances for each month that were unresolved within the 15 day window, the date the Contractor received the grievance and the date the Contractor reported the unresolved grievance to the Office of Guardianship.
  - (6) The year to date total number of treatment guardians under court appointment and the total number of clients being served in each location.

- (7) The year to date total contract amount expended. The quarterly report shall include a section stating the number of new clients for that quarter and the number of clients released from service
- (8) The quarterly report shall be submitted no later than the last day of the month following the end of the reporting quarter.

## J. Conflict of Interest

1. Contractor's Board Members and Other Contractors with the Agency.

The Contractor will make every effort to ensure that the membership on their Board of Directors does not have any conflicts of interest with the Agency's guardianship program. In some instances, an individual being served by the Agency may also be duly elected to the Board. In these occurrences, the contractor will give the Agency notice within 30 days of an expected appointment. In other instances, to avoid the appearance of impropriety, no one under contract with the Agency may serve on the Contractor's board of directors. (E.g. an attorney who performs petitioning services under contract for the Agency may not serve on the Contractor's board of directors.) If there is any question as to a conflict of interest of someone serving on the Contractor's board of directors under this term, then the Agency should be consulted prior to the appointment of the individual to the board.

2. Medicaid Waiver or DOH services

The Contractor warrants that it has no interest and shall not acquire any interest, direct or indirect, which would conflict in any manner or degree with the performance of services required under the contract or its duties and obligations to clients. The Contractor agrees further that they will not provide services to the same client under both this contract and the Medicaid Waiver program of the New Mexico Department of Health or other similar contracts. If no other alternative service provider is available in a community, the Contractor will disclose that information in writing and request permission from The Office of Guardianship to provide both services.

- K. <u>Outside Auditor</u> at the discretion of the Agency, an outside CPA may be brought in to audit the contractors billing for cases that are funded by the Agency. A two week advanced written notice of such an audit will be given to the Contractor.
- L. <u>Treatment of Others</u> the Contractor and its treatment guardianship service providers will treat all professional contacts with kindness and respect. The Agency will receive and investigate written complaints on the treatment of others against any contracted guardianship service provider. Hostility and aggression towards family members, friends, professionals or other service providers will NOT be tolerated. If after investigation, the incidence is found to have occurred, a reprimand may be issued and documented in the file of the contractor. After any such occurrence, possible sanctions or a corrective action plan may be implemented by the Agency.
- M. <u>No Overspending the Contract</u> the Contractor will not overspend this contract. There is no statutory requirement that the Agency pay for court appointments beyond the contracted amount. The Agency will not make payment to the contractor for any cases accepted after the contracted funds are expended. Because of the limitation on available funds, the Contractor may reserve the right to limit its acceptance of new guardianships.

- N. <u>Corrective Action Plan if</u> the Contractor fails to meet its performance or program related obligations under the negotiated contract, the Agency, at its sole discretion and depending on the circumstances, may implement a corrective action plan. The Agency shall notify the Contractor in writing of the deficiencies leading to the need for a corrective action plan.
  - (1) Upon receipt of the written notification, the Contractor shall develop a corrective action plan within twenty one (21) days addressing the following items:
    - (a) Identification of the problem and areas that need to be addressed;
    - (b) The "pro-active" steps to be taken to resolve the issues;
    - (c) The time frames necessary for completion of each step to be taken to resolve the issues; and
    - (d) The names of the persons responsible for each of the corrective action steps.

If the identified areas are addressed and resolved within thirty (30) days from the date of written notification by the Agency, a follow-up review will be conducted by the Agency and if all is found to be in compliance, the corrective action plan will not be implemented.

- (2) If a corrective action is necessary, then on the 31<sup>st</sup> day from the initial written notification, the Agency will implement a corrective action plan (CAP), the guardianship services contractor shall have a maximum of ninety (90) days to achieve full compliance with the CAP, such time to begin the effective date of the CAP. The Agency will withhold a percentage of funds otherwise due to the Contractor for each thirty (30) day period the Contractor remains in non-compliance with any deficiencies identified in the CAP. The Agency shall withhold 10% of the Contractor's invoiced amount for the first month of the CAP, 15% of the Contractor's invoiced amount for the second month of the CAP, and 20% of the invoiced amount for the third month of the CAP. The withholding for any given month shall remain in effect, even if the Contractor comes into compliance during that given month. The Agency shall proceed to terminate the Contractor's satisfaction within ninety (90) days after the effective date of the CAP.
- (3) The Agency, in its sole discretion may reallocate monies withheld as a sanction. The Contractor shall neither have claim upon nor opportunity to recoup monies withheld as a sanction.
- (4) The Agency will not impose further sanctions upon the determination that the Contractor has met its performance or program related obligations during a subsequent month. The payment process will then resume pursuant to the requirements of the contract.
- O. <u>Annual Contractors' Meeting</u> there will be an annual Contractors meeting. The Contractor will be charged with knowing and complying with all information presented at this meeting. Prior notification of meeting date, time and location will be sent to each Contractor 30 days in advance.
- P. <u>Civil Rights</u>: The contractor shall ensure that the client's civil rights are protected and that the client retains all legal and civil rights except those expressly given to the treatment guardian by the court, including but not limited to:

- (1) The right to be free from unlawful discrimination in mental health treatment;
- (2) The right to be treated humanely, with dignity and respect, and to be protected against emotional or psychological abuse, physical abuse, sexual abuse, neglect and exploitation;
- (3) The right to practice the religion of his/her choice, or to abstain from the practice of religion;
- (4) The right to receive visitors and communicate with others;
- (5) The right to privacy about their mental health treatment;
- (6) The right to voice grievances and complaints without interference, coercion or reprisal;
- (7) The right to receive mental health services to which they are entitled;
- (8) The right to be served in the most integrated setting appropriate to the needs of the client; and
- (9) The right to be restored to capacity for their own decision making on mental health care issues at the earliest possible times;
- Q. The contractor shall make sure that all services provided are designed to enhance, promote and expand the recovery, independence, self-sufficiency, self-esteem, and quality of life of the client being served by the treatment guardian.
- R. The contractor shall make sure that the clients are involved in the individual planning, decision-making, implementation and evaluation of services being provided to the client to the degree they are capable.
- S. The contractor will comply with the Office of Guardianships established procedures for the investigation and resolution of complaints against the contractor.
- T. Bid Bond. Enclosed with this proposal form is a bid bond in the amount of \$2,000. Proposals submitted without a bid bond attached will be deemed non-responsive (5% of the agency cost ceiling, not to exceed \$2,000). Checks <u>WILL NOT</u> be accepted. A "Letter of Credit/Guarantee" as defined in Section 1.D.6, is acceptable.

## 2. Compensation.

- A. The total amount of compensation paid to the Contractor under this agreement **shall not exceed \$200,000.00** per fiscal year in full payment for services rendered. The Agency shall not pay gross receipts tax on the total sum to the Contractor and the Contractor shall neither bill nor collect gross receipts tax for these services.
- B. The Agency shall pay to the Contractor two hundred forty-five dollars (\$245.00) per nonfamilial court appointment. The Contractor will pay the Treatment Guardians \$200 per client per Court appointment.
- C. The Agency shall pay the Contractor upon receipt of a detailed statement of accounting for services performed, with:
  - (1) A list of all clients and the treatment guardians' social security number, address and phone number along with the client's contact information will be provided to the Office of Guardianship.
  - (2) A copy of the Court Order appointing the treatment guardian with the term of the appointment (date of appointment and expiration).
  - (3) itemized statement of services rendered to the client. (Coding may be used by the Contractor, but a list identifying all codes must be provided to the Agency).

Description of duties performed for the protected person, with appropriate signatures verifying the services were received.

- (4) The contract reference number will be placed on each request for payment;
- (5) Each billing cycle will end on the last day of the month. No overlapping of bills or duplication of bills for services already billed will be allowed.
- (6) The Criminal Background check requirement of the Caregiver's Criminal History Screening Act;
- (7) Any other information that agency and contractor agree upon to assure quality of service and guarantee treatment guardian accountability.
- D. If the Agency finds that the services are not acceptable, within thirty days after the date of receipt of written notice from the Contractor that payment is requested, it shall provide the Contractor a letter of exception explaining the defect or objection to the services, and outlining steps the Contractor may take to provide remedial action for possible payment. Upon certification by the Agency that the services have been received and accepted, payment shall be tendered to the Contractor within thirty days after the date of acceptance. The agency shall not incur late charges, interest, or penalties for failure to make payment within the time specified herein.

## 3. <u>Term</u>.

THIS AGREEMENT SHALL NOT BECOME EFFECTIVE UNTIL APPROVED BY THE DFA. This Agreement shall terminate on **June 30**, **2014** unless terminated pursuant to paragraph 4, <u>infra</u>, paragraph 5 or as otherwise allowed in this agreement. In accordance with Section 13-1-150 NMSA 1978, no contract term for a professional services contract, including extensions and renewals, shall exceed four years, except as set forth in Section 13-1-150 NMSA 1978.

## 4. <u>Termination.</u>

A. <u>Termination</u>. This Agreement may be terminated by either of the parties hereto upon written notice delivered to the other party at least thirty (30) days prior to the intended date of termination. Except as otherwise allowed or provided under this Agreement, the Agency's sole liability upon such termination shall be to pay for acceptable work performed prior to the Contractor's receipt of the notice of termination, if the Agency is the terminating party, or the Contractor's sending of the notice of termination, if the Contractor is the terminating party; provided, however, that a notice of termination shall not nullify or otherwise affect either party's liability for pre-termination defaults under or breaches of this Agreement. The Contractor shall submit an invoice for such work within thirty (30) days of receiving or sending the notice of termination. Notwithstanding the foregoing, this Agreement may be terminated immediately upon written notice to the Contractor if the Contractor becomes unable to perform the services contracted for, as determined by the Agency or if, during the term of this Agreement, the Contractor or any of its officers, employees or agents is indicted for fraud, embezzlement or other crime due to misuse of state funds or due to the Appropriations paragraph herein. THIS PROVISION IS NOT EXCLUSIVE AND DOES NOT WAIVE THE STATE'S OTHER LEGAL RIGHTS AND REMEDIES CAUSED BY THE CONTRACTOR'S DEFAULT/BREACH OF THIS AGREEMENT.

B. Termination Management. Immediately upon receipt by either the Agency or the

Contractor of notice of termination of this Agreement, the Contractor shall: 1) not incur any further obligations for salaries, services or any other expenditure of funds under this Agreement without written approval of the Agency; 2) comply with all directives issued by the Agency in the notice of termination as to the performance of work under this Agreement; and 3) take such action as the Agency shall direct for the protection, preservation, retention or transfer of all property titled to the Agency and records generated under this Agreement. Any non-expendable personal property or equipment provided to or purchased by the Contractor with contract funds shall become property of the Agency upon termination and shall be submitted to the agency as soon as practicable.

#### 5. Appropriations.

The terms of this Agreement are contingent upon sufficient appropriations and authorization being made by the Legislature of New Mexico for the performance of this Agreement. If sufficient appropriations and authorization are not made by the Legislature, this Agreement shall terminate immediately upon written notice being given by the Agency to the Contractor. The Agency's decision as to whether sufficient appropriations are available shall be accepted by the Contractor and shall be final. If the Agency proposes an amendment to the Agreement to unilaterally reduce funding, the Contractor shall have the option to terminate the Agreement or to agree to the reduced funding, within thirty (30) days of receipt of the proposed amendment.

#### 6. <u>Status of Contractor</u>.

The Contractor and its agents and employees are independent contractors performing professional services for the Agency and are not employees of the State of New Mexico. The Contractor and its agents and employees shall not accrue leave, retirement, insurance, bonding, use of state vehicles, or any other benefits afforded to employees of the State of New Mexico as a result of this Agreement. The Contractor acknowledges that all sums received hereunder are reportable by the Contractor for tax purposes, including without limitation, self-employment and business income tax. The Contractor agrees not to purport to bind the State of New Mexico unless the Contractor has express written authority to do so, and then only within the strict limits of that authority.

#### 7. Assignment.

The Contractor shall not assign or transfer any interest in this Agreement or assign any claims for money due or to become due under this Agreement without the prior written approval of the Agency.

#### 8. <u>Subcontracting</u>.

The Contractor shall not subcontract any portion of the services to be performed under this Agreement without the prior written approval of the Agency. No such subcontract shall relieve the primary Contractor from its obligations and liabilities under this Agreement, nor shall any subcontract obligate direct payment from the Procuring Agency.

#### 9. <u>Release</u>.

Final payment of the amounts due under this Agreement shall operate as a release of the Agency, its officers and employees, and the State of New Mexico from all liabilities, claims and obligations whatsoever arising from or under this Agreement.

# 10. <u>Confidentiality</u>.

Any confidential information provided to or developed by the Contractor in the performance of this Agreement shall be kept confidential and shall not be made available to any individual or organization by the Contractor without the prior written approval of the Agency.

## 11. <u>Product of Service -- Copyright.</u>

All materials developed or acquired by the Contractor under this Agreement shall become the property of the State of New Mexico and shall be delivered to the Agency no later than the termination date of this Agreement. Nothing developed or produced, in whole or in part, by the Contractor under this Agreement shall be the subject of an application for copyright or other claim of ownership by or on behalf of the Contractor.

## 12. <u>Conflict of Interest; Governmental Conduct Act.</u>

A. The Contractor represents and warrants that it presently has no interest and, during the term of this Agreement, shall not acquire any interest, direct or indirect, which would conflict in any manner or degree with the performance or services required under the Agreement.

B. The Contractor further represents and warrants that it has complied with, and, during the term of this Agreement, will continue to comply with, and that this Agreement complies with all applicable provisions of the Governmental Conduct Act, Chapter 10, Article 16 NMSA 1978. Without in anyway limiting the generality of the foregoing, the Contractor specifically represents and warrants that:

1) in accordance with Section 10-16-4.3 NMSA 1978, the Contractor does not employ, has not employed, and will not employ during the term of this Agreement any Agency employee while such employee was or is employed by the Agency and participating directly or indirectly in the Agency's contracting process;

2) this Agreement complies with Section 10-16-7(A) NMSA 1978 because (i) the Contractor is not a public officer or employee of the State; (ii) the Contractor is not a member of the family of a public officer or employee of the State; (iii) the Contractor is not a business in which a public officer or employee or the family of a public officer or employee has a substantial interest; or (iv) if the Contractor is a public officer or employee of the State, a member of the family of a public officer or employee of the State, or a business in which a public officer or employee of the State or the family of a public officer or employee of the State has a substantial interest, public notice was given as required by Section 10-16-7(A) NMSA 1978 and this Agreement was awarded pursuant to a competitive process;

3) in accordance with Section 10-16-8(A) NMSA 1978, (i) the Contractor is not, and has not been represented by, a person who has been a public officer or employee of the State within the preceding year and whose official act directly resulted in this Agreement and (ii) the Contractor is not, and has not been assisted in any way regarding this transaction by, a former public officer or employee of the State whose official act, while in State employment, directly resulted in the Agency's making this Agreement;

4) this Agreement complies with Section 10-16-9(A) NMSA 1978 because (i) the Contractor is not a legislator; (ii) the Contractor is not a member of a legislator's family; (iii) the Contractor is not a business in which a legislator or a legislator's family has a substantial interest; or (iv) if the Contractor is a legislator, a member of a legislator's family, or a business in which a legislator or a legislator's family has a substantial interest, disclosure has been made as required by Section 10-16-9(A) NMSA 1978, this Agreement is not a sole source or small purchase contract, and this Agreement was awarded in accordance with the provisions of the Procurement Code;

5) in accordance with Section 10-16-13 NMSA 1978, the Contractor has not directly participated in the preparation of specifications, qualifications or evaluation criteria for this Agreement or any procurement related to this Agreement; and

6) in accordance with Section 10-16-3 and Section 10-16-13.3 NMSA 1978, the Contractor has not contributed, and during the term of this Agreement shall not contribute, anything of value to a public officer or employee of the Agency.

C. Contractor's representations and warranties in Paragraphs A and B of this Article 12 are material representations of fact upon which the Agency relied when this Agreement was entered into by the parties. Contractor shall provide immediate written notice to the Agency if, at any time during the term of this Agreement, Contractor learns that Contractor's representations and warranties in Paragraphs A and B of this Article 12 were erroneous on the effective date of this Agreement or have become erroneous by reason of new or changed circumstances. If it is later determined that Contractor's representations and warranties in Paragraphs A and B of this Agreement or have become erroneous on the effective date of this Agreement or have become erroneous on the effective date of this Agreement or have become erroneous on the effective date of this Agreement or have become erroneous on the effective date of this Agreement or have become erroneous on the effective date of this Agreement or have become erroneous on the effective date of this Agreement or have become erroneous on the effective date of this Agreement or have become erroneous on the effective date of this Agreement or have become erroneous by reason of new or changed circumstances, in addition to other remedies available to the Agency and notwithstanding anything in the Agreement to the contrary, the Agency may immediately terminate the Agreement.

D. All terms defined in the Governmental Conduct Act have the same meaning in this Article 12(B).

## 13. <u>Amendment</u>.

A. This Agreement shall not be altered, changed or amended except by instrument in writing executed by the parties hereto and all other required signatories.

B. If the Agency proposes an amendment to the Agreement to unilaterally reduce funding due to budget or other considerations, the Contractor shall, within thirty (30) days of receipt of the proposed Amendment, have the option to terminate the Agreement, pursuant to the termination provisions as set forth in Article 4 herein, or to agree to the reduced funding.

## 14. <u>Merger</u>.

This Agreement incorporates all the Agreements, covenants and understandings between the parties hereto concerning the subject matter hereof, and all such covenants, Agreements and understandings have been merged into this written Agreement. No prior Agreement or understanding, oral or otherwise, of the parties or their agents shall be valid or enforceable unless embodied in this Agreement.

### 15. <u>Penalties for violation of law.</u>

The Procurement Code, Sections 13-1-28 through 13-1-199, NMSA 1978, imposes civil and criminal penalties for its violation. In addition, the New Mexico criminal statutes impose felony penalties for illegal bribes, gratuities and kickbacks.

## 16. <u>Equal Opportunity Compliance</u>.

The Contractor agrees to abide by all federal and state laws and rules and regulations, and executive orders of the Governor of the State of New Mexico, pertaining to equal employment opportunity. In accordance with all such laws of the State of New Mexico, the Contractor assures that no person in the United States shall, on the grounds of race, religion, color, national origin, ancestry, sex, age, physical or mental handicap, or serious medical condition, spousal affiliation, sexual orientation or gender identity, be excluded from employment with or participation in, be denied the benefits of, or be otherwise subjected to discrimination under any program or activity performed under this Agreement. If Contractor is found not to be in compliance with these requirements during the life of this Agreement, Contractor agrees to take appropriate steps to correct these deficiencies.

# 17. <u>Applicable Law.</u>

The laws of the State of New Mexico shall govern this Agreement, without giving effect to its choice of law provisions. Venue shall be proper only in a New Mexico court of competent jurisdiction in accordance with Section 38-3-1 (G) NMSA 1978. By execution of this Agreement, Contractor acknowledges and agrees to the jurisdiction of the courts of the State of New Mexico over any and all lawsuits arising under or out of any term of this Agreement.

# 18. <u>Workers Compensation</u>.

The Contractor agrees to comply with state laws and rules applicable to workers compensation benefits for its employees. If the Contractor fails to comply with the Workers Compensation Act and applicable rules when required to do so, this Agreement may be terminated by the Agency.

## **19.** <u>Records and Financial Audit</u>.

The Contractor shall maintain detailed time and expenditure records that indicate the date; time, nature and cost of services rendered during the Agreement's term and effect and retain them for a period of three (3) years from the date of final payment under this Agreement. The records shall be subject to inspection by the Agency, the Department of Finance and Administration and the State Auditor. The Agency shall have the right to audit billings both before and after payment. Payment under this Agreement shall not foreclose the right of the Agency to recover excessive or illegal payments

## 20. <u>Indemnification</u>.

The Contractor shall defend, indemnify and hold harmless the Agency and the State of New Mexico from all actions, proceeding, claims, demands, costs, damages, attorneys' fees and all other liabilities and expenses of any kind from any source which may arise out of the performance of this Agreement, caused by the negligent act or failure to act of the Contractor, its officers, employees, servants, subcontractors or agents, or if caused by the actions of any client of the Contractor resulting in injury or damage to persons or property during the time when the Contractor or any officer, agent, employee, servant or subcontractor thereof has or is performing services pursuant to this Agreement. In the event that any action, suit or proceeding related to the services performed by the Contractor or any officer, agent, employee, servant or subcontractor, the Contractor shall, as soon as practicable but no later than two (2) days after it receives notice thereof, notify the legal

counsel of the Agency and the Risk Management Division of the New Mexico General Services Department by certified mail.

## 21. <u>New Mexico Employees Health Coverage.</u>

A. If Contractor has, or grows to, six (6) or more employees who work, or who are expected to work, an average of at least 20 hours per week over a six (6) month period during the term of the contract, Contractor certifies, by signing this agreement, to have in place, and agree to maintain for the term of the contract, health insurance for those employees and offer that health insurance to those employees if the expected annual value in the aggregate of any and all contracts between Contractor and the State exceed \$250,000 dollars.

B. Contractor agrees to maintain a record of the number of employees who have (a) accepted health insurance; (b) declined health insurance due to other health insurance coverage already in place; or (c) declined health insurance for other reasons. These records are subject to review and audit by a representative of the state.

C. Contractor agrees to advise all employees of the availability of State publicly financed health care coverage programs by providing each employee with, as a minimum, the following web site link to additional information: <u>http://insurenewmexico.state.nm.us/</u>.

# 22. <u>Employee Pay Equity Reporting</u>

Contractor agrees if it has ten (10) or more New Mexico employees OR eight (8) or more employees in the same job classification, at any time during the term of this contract, to complete and submit the PE10-249 form on the annual anniversary of the initial report submittal for contracts up to one (1) year in duration. If contractor has (250) or more employees contractor must complete and submit the PE250 form on the annual anniversary of the initial report submittal for contracts up to one (1) year in duration. For contracts that extend beyond one (1) calendar year, or are extended beyond one (1) calendar year, contractor also agrees to complete and submit the PE10-249 or PE250 form, whichever is applicable, within thirty (30) days of the annual contract anniversary date of the initial submittal date or, if more than 180 days has elapsed since submittal of the last report, at the completion of the contract, whichever comes first. Should contractor not meet the size requirement for reporting at contract award but subsequently grows such that they meet or exceed the size requirement for reporting, contractor agrees to provide the required report within ninety (90 days) of meeting or exceeding the size requirement. That submittal date shall serve as the basis for submittals required thereafter. Contractor also agrees to levy this requirement on any subcontractor(s) performing more than 10% of the dollar value of this contract if said subcontractor(s) meets, or grows to meet, the stated employee size thresholds during the term of the contract. Contractor further agrees that, should one or more subcontractor not meet the size requirement for reporting at contract award but subsequently grows such that they meet or exceed the size requirement for reporting, contractor will submit the required report, for each such subcontractor, within ninety (90 days) of that subcontractor meeting or exceeding the size requirement. Subsequent report submittals, on behalf of each such subcontractor, shall be due on the annual anniversary of the initial report submittal. Contractor shall submit the required form(s) to the State Purchasing Division of the General Services Department, and other departments as may be determined, on behalf of the applicable subcontractor(s) in accordance with the schedule contained in this paragraph.

Contractor acknowledges that this subcontractor requirement applies even though contractor itself may not meet the size requirement for reporting and be required to report itself.

Notwithstanding the foregoing, if this Contract was procured pursuant to a solicitation, and if Contractor has already submitted the required report accompanying their response to such solicitation, the report does not need to be re-submitted with this Agreement.

### 23. <u>Invalid Term or Condition</u>.

If any term or condition of this Agreement shall be held invalid or unenforceable, the remainder of this Agreement shall not be affected and shall be valid and enforceable.

### 24. <u>Enforcement of Agreement</u>.

A party's failure to require strict performance of any provision of this Agreement shall not waive or diminish that party's right thereafter to demand strict compliance with that or any other provision. No waiver by a party of any of its rights under this Agreement shall be effective unless express and in writing, and no effective waiver by a party of any of its rights shall be effective to waive any other rights.

### <u>Attachment 1</u> <u>Performance Measures</u>

<u>**Goals**</u>: To provide trained mental health treatment guardians as a last resort (where no one else is available) for appointment by the Courts for individuals who cannot provide informed consent for their mental health treatment or medication.

### **Objectives:**

- 1) Provide the number of mental health treatment guardianship required by the Courts for appointments as allowed by the compensation section of this contract.
- 2) Conduct outreach activities, recruitment campaigns for Treatment Guardians, and provide education/training sessions and refresher training for anyone interested. Serve as an educational resource for local organizations related to treatment guardians.
- 3) Provide a Training Manual, Handbook, and brochure re: Treatment Guardians. Distribute the mental health treatment guardian educational/training material to judges, newly appointed treatment guardians, mental health personnel, volunteers, and anyone else interested re: mental health treatment guardians.
- 4) The expectations for Treatment Guardians include:
  - making mental health care decisions on behalf of the client, including:
    - the client's "best interest" and least drastic means for accomplishing the treatment objective.
    - consulting with the client and considering the client's expressed opinions, and consider client's previous decisions when had capacity.
    - consulting with the physician or other professional proposing treatment, the client's attorney, interested friends, relatives, or other agents or guardians to the extent reasonably practicable in making a decision.
  - communicating all pertinent information to the protected person, unless reasonably certain that substantial harm will result. Also communicating with family members or other care givers when doing so would benefit the client and reasonably certain that substantial harm will not result.
  - participating in the development of the Treatment Plan and follow-up re: compliance, needed changes, etc.
  - participating in the development of the Discharge Plan and involve the family as appropriate.
  - may seek an Enforcement Order from the Court for clients who are not a resident of a medical facility and for whom a treatment guardian has been appointed, who refuses to comply with the decision of the treatment guardian. Such an order may authorize a peace officer to take the person into custody and to transport the client to an evaluation facility and may authorize the facility to forcibly administer treatment.
- 5) Monitor and conduct on-going oversight of Treatment Guardians paid under this contract.
- 6) Provide a Monthly Report to the Agency as specified in this contract.
- 7) Provide a process for clients and family members to report problems and complaints.
- 8) Apply the Caregiver's Criminal History Screening Act as to every treatment guardian.
- 9) Provide a quarterly report to the Agency as specified in this contract.

## **APPENDIX F**

#### **Business Associate Agreement**

This is a business associate agreement in compliance with 45 CFR Section 160-504(e)(2) of the HIPAA privacy rule. Contractor understands that it may be considered a business associate of the NMDDPC under the HIPAA Privacy and Security Rules. Accordingly, the parties agree:

The disclosures NMDDPC will make to Contractor of any information that identifies an individual and includes information about the individual's health (protected health information), whether in electronic or physical form, shall be limited to the minimum reasonably necessary for Contractor's delivery of services described in the Scope of Agreement to which the parties have agreed to in the Contract.

Any disclosures by Contractor of the individual's protected health information inconsistent with this agreement are strictly prohibited and shall be cause for termination of the Contract. Contractor shall take all reasonable steps to avoid such disclosures, including but not limited to implementation of all practical administrative, physical and technical safeguards.

After the expiration of this Contract, whether because a party has cancelled it, it is fully executed or for any other cause, Contractor shall return all documents containing the individuals protected health information to the NMDDPC. Contractor also agrees that it shall take reasonable affirmative precautions to avoid any unauthorized disclosures of protected health information to third parties.

Contractor understands it is responsible for reporting unauthorized disclosures, including but not limited to electronic security violations, to the NMDDPC privacy office or the federal Office of Civil Rights. Contractor also understands it is responsible for reporting any other disclosure for purposes other than treatment, payment or operations to the NMDDPC privacy office.

Contractor agrees to bind their agents and subcontractors to the terms of this agreement.

Contractor understands an individual has the right to inspect and request changes to the protected health information to the parties use or create and that an appropriate privacy officer or the federal Office of Civil Rights has the authority to inspect the parties' procedures for management of the individual's protected health information.

This agreement is effective on June 1, 2013 and shall terminate on June 30, 2016.

# APPENDIX H CAMPAIGN CONTRIBUTION DISCLOSURE FORM

Pursuant to NMSA 1978, §13-1-191.1 (2006), any person seeking to enter into a contract with any state agency or local public body for professional services, a design and build project delivery system or the design and installation of measures the primary purpose of which is to conserve natural resources must file this form with that state agency or local public body. "Family member" means spouse, father, mother, child, father-in-law, mother-in-law, daughter-in-law or son-in-law.

**"Pendency of the procurement process"** means the time period commencing with the public notice of the request for proposals and ending with the award of the contract or the cancellation of the request for proposals.

"**Person**" means any corporation, partnership, individual, joint venture, association or any other private legal entity.

**"Prospective contractor"** means a person who is subject to the competitive sealed proposal process set forth in the Procurement Code or is not required to submit a competitive sealed proposal because that person qualifies for a sole source or a small purchase contract.

**"Representative of a prospective contractor"** means an officer or director of a corporation, a member or manager of a limited liability corporation, a partner of a partnership or a trustee of a trust of the prospective contractor.
