**Call to Order/Introductions/Housekeeping**

John Arango called the meeting to order, completed the roll call, and housekeeping was conducted. The meeting convened at 2:10 PM.

**Approval of November 9, 2020 Agenda – Action Item**

**Executive Director Report – Alice Liu McCoy**

Reported on DDPC fiscal year 2022 budget update and actions that have been and will be undertaken to advocate for increasing the Executive (DFA) and Legislative (LFC) budget recommendations. John Arango discussed the agency audit. Discussed Office of Guardianship vacancies and impact on guardianship program if budget is not right-sized.

Gary Housepian and Alice Liu McCoy reported on DDPC’s presentation to the Governor’s Advisory Council on Racial Justice. Alice discussed seeking partners to work on domestic/sexual violence and human trafficking and abuse/neglect/exploitation priorities.

Diane Mourning-Brown, Elisheva Levin, and Alice Liu Cook reported on DVR issues, including lack of job openings and reducing the waitlist. Elisheva Levin discussed the THRIVE program for people on the spectrum. Chinda Lucoski discussed Project SEARCH.
