# I. INTRODUCTION

# A. PURPOSE OF THIS REQUEST FOR PROPOSALS

The purpose of the Request for Proposal (RFP) is to solicit sealed proposals to establish a contract through competitive negotiations for the procurement of the New Mexico Developmental Disabilities Planning Council, Office of Guardianship (DDPC) to invite private or public entities or individuals (Offerors) familiar with and experienced in court appointed guardianship services. Successful Offeror(s) will provide court appointed guardianship services as defined in the Scope of Work and in the sample contract. Offeror(s) may propose to deliver services statewide or within a limited geographical area.

#### SUMMARY SCOPE OF WORK

The contractor shall provide guardianship services to New Mexico residents who are eighteen (18) years old or older, who are financially eligible for Medicaid or a similar public benefit, and who have been adjudicated as incapacitated. The contractor shall be the "guardian of last resort" where there is no family member or other qualified person who is willing, able, and suitable to be guardian.

#### BACKGROUND

- A. Statutorily, the Developmental Disabilities Planning Council (DDPC) Office of Guardianship is the State entity responsible for administration of providing guardianship services as the last resort for New Mexico residents who are low income eligible incapacitated adults, and to monitor contracts that provide guardianship services.
- B. DDPC contracts with entities, companies and organizations (Contractors) to provide professional guardianship services to act as guardian for an adjudicated incapacitated adult who has no family or friends willing, able and appropriate to be their guardian. DDPC provides a flat rate monthly payment to the Contractor for each protected person served. Contractors are required to be certified by the Center for Guardianship Certification (CGC).
- C. DDPC is issuing this RFP to solicit proposals to contract with DDPC Office of Guardianship for providing professional guardianship services.

# **QUALIFICATIONS FOR PROFESSIONAL GUARDIANS/CONTRACTORS**

Contractor must be a CGC-certified guardian.

Contractor shall employ or contract with certified guardianship coordinators who, as determined by education and experience, are competent to perform the contracted guardianship services, and who either possess CGC certification or successfully obtain certification, as required within the Professional Services Contract Scope of Work. Contractor shall ensure that all decisions made on behalf of a protected person, as per the scope of the guardianship order, are made by a certified guardian.

Contractor and its guardianship coordinators and/or subcontractors shall comply with the Caregiver's Criminal History Screening Act (CCHSA), (NMSA 1978, § 29-17-5) and the Contractor shall comply with the requirements of the Act and the Caregiver's Criminal History Screening Requirements, (7.1.9 NMAC).

Contractor shall not employ any person who has been excluded from the Medicare or Medicaid Programs.

Contractor shall ensure that CGC-certified guardianship coordinator(s) do not carry a caseload of more than thirty (30) Protected Persons.

Contractors shall ensure that at least one in-person individual face-to-face visit per month is conducted and documented.

Contractor shall ensure that the protected person receives services that are of the highest degree possible and are designed to enhance, promote and expand independence, self-sufficiency, self-esteem, and the quality of life of a protected person.

## MINIMUM QUALIFICATIONS:

Meet the Office of Guardianship requirements, including but not limited to:

- 1. Comply with all terms of one's contract;
- 2. Agree to be paid at the State approved rate;
- 3. Comply with the Caregivers Criminal History Screening Act (See NMSA 1978 § 29-17-5);
- 4. Must be a CGC-certified guardian prior to award of contract;
- 5. Assure the civil rights of the protected person;
- 6. Guarantee access to all records on protected persons assigned through the Office of Guardianship.
- 7. Must have written policy and procedures; and
- 8. Comply with the following legal authority and guardianship practices, including but not limited to the:
  - a. Uniform Probate Code (NMSA 1978 § 45-5-101 to 315);
  - b. Office of Guardianship Act (NMSA 1978 § 28-16B-1 to 6);

- c. Uniform Health-Care Decisions Act (NMSA 1978 § 24-7A-1 to 18);
- d. Mental Health Care Treatment Decisions Act (NMSA 1978 § 24-7B-1 to 6);
- e. Adult Protective Services Act (NMSA 1978 § 27-7-1 to 31);
- f. Rules of the Office of Guardianship (9.4.21 NMAC);
- g. National Guardianship Association: Standards of Practice; Ethical Principles for Guardians; and Standards for Agencies and Programs Providing Guardianship Services; and
- h. Scope of the order appointing Contractor as guardian.

# A. SCOPE OF PROCUREMENT

The scope of procurement shall encompass the requirements in the contract (Appendix E of this RFP). The proposed contract will be effective the date of signature of the New Mexico Department of Finance and Administration (DFA).

The initial term for the contract is expected to be July 1, 2020 through June 30, 2021, with renegotiation of the contractual terms for the purpose of continuing the services described in this RFP and additional services and funding as needed and available. The DDPC reserves the option of renewing the initial contract(s) on an annual basis for three (3) additional years or any portion thereof for the purpose of providing continued services based on contractor performance and availability of funding. In no case will the contract, including all renewals thereof, exceed a total of four (4) years in duration.

The total amount available for contracting these services in FY 2020 will be subject to appropriation. Funding will be derived, as available, from DDPC.

#### PLEASE NOTE:

• If this is a procurement that will result in a contractual agreement between two parties, the procurement may ONLY be used by those two parties exclusively.

#### OFFEROR QUALIFICATIONS/CONFLICT OF INTEREST

This RFP is open to any Offeror capable of performing the work described in Section IV Mandatory Specifications, subject to the following stipulations:

- 1. Pursuant to the Governmental Conduct Act, NMSA 1978, Sections 10-16 et. seq., an Offeror will have no direct or indirect interest that conflicts with the performance of services covered under this RFP;
- 2. Pursuant to NMSA 1978 Sections 13-19-191, and 30-41-1 through 30-41-3, an Offeror may not provide or offer bribes, gratuities, or kickbacks to applicable state personnel;

- 3. An Offeror shall ensure that no elected or appointed officer or other employee of the State of New Mexico shall benefit financially or materially from the successful award of the contract to the Offeror and that no such individual shall be admitted to any share or part of the contract or to any benefit that may arise therefrom;
- 4. The burden is on the Offeror to present sufficient assurance to the DDPC that the award of the contract to the Offeror shall not create a conflict of interest.

2. Any inquiries or requests regarding this procurement should be submitted, in writing, to the Procurement Manager. Offerors may contact ONLY the Procurement Manager regarding this procurement. Other state employees or Evaluation Committee members do not have the authority to respond on behalf of the State Purchasing Division of the New Mexico State General Services Department (State Purchasing Department). Protests of the solicitation or award must be delivered by mail to the Kathleen Coates. As a Protest Manager has been named in this Request for Proposals, pursuant to NMSA 1978, § 13-1-172, ONLY protests delivered directly to the Protest Manager (Kathleen Coates) in writing and in a timely fashion will be considered to have been submitted properly and in accordance with statute, rule and this Request for Proposals. Emailed protests will not be considered as properly submitted nor will protests delivered to the Procurement Manager be considered properly submitted.

# C. DEFINITION OF TERMINOLOGY

This section contains definitions of terms used throughout this procurement document, including appropriate abbreviations:

"Agency" means the State Purchasing Division of the General Services Department or that State Agency sponsoring the Procurement action.

"Authorized Purchaser" means an individual authorized by a Participating Entity to place orders against this contract.

"Award" means the final execution of the contract document.

"Business Hours" means 8:00 AM thru 5:00 PM Mountain Standard or Mountain Daylight Time,

"Close of Business" means 5:00 PM Mountain Standard or Daylight Time.

"**Confidential**" means confidential financial information concerning offeror's organization and data that qualifies as a trade secret in accordance with the Uniform Trade Secrets Act NMSA 1978 57-3-A-1 to 57-3A-7. See NMAC 1.4.1.45. As one example, no information that could be obtained from a source outside this request for proposals can be considered confidential information.

"**Contract**" means any agreement for the procurement of items of tangible personal property, services or construction.

"Contractor" means any business having a contract with a state agency or local public body.

"**Contract Manager**" means the individual designated by DDPC to monitor and manage all aspects of the contracts resulting from this RFP, including directing the work of the contractor.

"**Determination**" means the written documentation of a decision of a procurement offer, including findings of fact required to support a decision. A determination becomes part of the procurement file to which it pertains.

**"Deliverable"** means any measurable, tangible, verifiable outcome, result or item that must be produced to complete a project or part of a project.

"**Desirable**" the terms "may", "can", "should", "preferably", or "prefers" identify a desirable or discretionary item or factor.

"CRB" Contract Review Bureau located at General Services State Purchasing Division for the State of New Mexico.

"**Electronic Version/Copy**" means a digital form consisting of text, images or both readable on computers or other electronic devices that includes all content that the Original and Hard Copy proposals contain. The digital form may be submitted using a compact disc (cd) or USB flash drive. The electronic version/copy can NOT be emailed.

"Evaluation Committee" means a body appointed to perform the evaluation of Offerors' proposals.

**"Evaluation Committee Report**" means a report prepared by the Procurement Manager and the Evaluation Committee for contract award. It will contain written determinations resulting from the procurement.

"Factor" means a section of the RFP that requires a response.

"**Finalist**" means an Offeror who meets all the mandatory specifications of this Request for Proposals and whose score on evaluation factors is sufficiently high to merit further consideration by the Evaluation Committee.

"**Rate**" means the proposed fully loaded maximum hourly rates that include travel, per diem, fringe benefits and any overhead costs for contractor personnel, as well as subcontractor personnel if appropriate.

"IT" means Information Technology.

"**Mandatory**" – the terms "must", "shall", "will", "is required", or "are required", identify a mandatory item or factor. Failure to meet a mandatory item or factor will result in the rejection of the Offeror's proposal.

"Minor Technical Irregularities" means anything in the proposal that does not affect the price quality and quantity or any other mandatory requirement.

"Offeror" is any person, corporation, or partnership who chooses to submit a proposal.

**"Performance Measure"** means a unit of evaluation specified by the state that enables performance to be determined.

**"Procurement Code"** means the law that governs the process of procurement for the State of New Mexico.

"Procurement Code Regulations" means General Services (GSD).

"**Procurement Manager**" means any person or designee authorized by a state agency or local public body to enter into or administer contracts and make written determinations with respect thereto.

"**Procuring Agency**" means all State of New Mexico agencies, commissions, institutions, political subdivisions and local public bodies allowed by law to entertain procurements.

"**Redacted**" means a version/copy of the proposal with the information considered confidential as defined by NMAC 1.4.1.45 and defined herein and outlined in Section II.C.8 of this RFP blacked out BUT NOT omitted or removed.

"**Request for Proposals (RFP)**" means all documents, including those attached or incorporated by reference, used for soliciting proposals.

"**Responsible Offeror**" means an Offeror who submits a responsive proposal and who has furnished, when required, information and data to prove that his financial resources, production or service facilities, personnel, service reputation and experience are adequate to make satisfactory delivery of the services, or items of tangible personal property described in the proposal.

"**Responsive Offer**" or means an offer which conforms in all material respects to the requirements set forth in the request for proposals. Material respects of a request for proposals include, but are not limited to price, quality, quantity or delivery requirements.

"Sealed" means, in terms of a non-electronic submission, that the proposal is enclosed in a package which is completely fastened in such a way that nothing can be added or removed. Open packages submitted will not be accepted except for packages that may have been damaged by the delivery service itself. The State reserves the right, however, to accept or reject packages where there may have been damage done by the delivery service itself. Whether a package has been damaged by the delivery service or left unfastened and should or should not be accepted is a determination to be made by the Procurement Manager. By submitting a proposal, the Offeror agrees to and concurs with this process and accepts the determination of the Procurement Manager in such cases.

"SPD" means State Purchasing Division of the New Mexico State General Services Department.

"**Staff**" means any individual who is a full-time, part-time, or an independently contracted employee with the Offerors' company.

"State (the State)" means the State of New Mexico.

"**State Agency**" means any department, commission, council, board, committee, institution, legislative body, agency, government corporation, educational institution or official of the executive, legislative or judicial branch of the government of this state. "State agency" includes the purchasing division of the general services department and the state purchasing agent but does not include local public bodies.

"State Purchasing Agent" means the director of the purchasing division of the general services department.

"**Statement of Concurrence**" means an affirmative statement from the Offeror to the required specification agreeing to comply and concur with the stated requirement(s). This statement shall be included in Offerors proposal. (E.g. "We concur", "Understands and Complies", "Comply", "Will Comply if Applicable" etc.)

**"Subcontractor"** means a person or business which has a contract (as an "independent contractor" and not an employee) with a contractor to provide some portion of the guardianship services which the contractor has agreed to perform.

"**Unredacted**" means a version/copy of the proposal containing all complete information including any that the Offeror would otherwise consider confidential, such copy for use only for the purposes of evaluation.

#### 1. Issuance of RFP

This RFP is being issued on behalf of the New Mexico State Developmental Disabilities Planning Council on January 26, 2020.

#### 2. Acknowledgement of Receipt

Potential Offerors should hand deliver, return by facsimile or registered or certified mail the "Acknowledgement of Receipt of Request for Proposals Form" that accompanies this document, APPENDIX A, to have their organization placed on the procurement distribution list. The form should be signed by an authorized representative of the organization, dated and returned to the Procurement Manager by 5:00 pm MST or MDT on February 4, 2020.

The procurement distribution list will be used for the distribution of written responses to questions. Failure to return the Acknowledgement of Receipt form shall constitute a presumption of receipt and rejection of the RFP, and the potential Offeror's organization name shall not appear on the distribution list.

#### 3. Pre-Proposal Conference

Proposals must be sealed and labeled on the outside of the package to clearly indicate that they are in response to the Office of Guardianship-Professional Guardianship Services; 647-P737-07-01-2020-FY21. Proposals submitted by facsimile, or other electronic means other than through the SPD electronic e-procurement system, will not be accepted.

A public log will be kept of the names of all Offeror organizations that submitted proposals. Pursuant to NMSA 1978, § 13-1-116, the contents of proposals shall not be disclosed to competing potential Offerors during the negotiation process. The negotiation process is deemed to be in effect until the contract is awarded pursuant to this Request for Proposals. Awarded in this context means the final required state agency signature on the contract(s) resulting from the procurement has been obtained.

#### 7. Proposal Evaluation

An Evaluation Committee will perform the evaluation of proposals. This process will take place as indicated in the sequence of events, depending upon the number of proposals received. During this time, the Procurement Manager, Kathleen Coates may initiate discussions with Offerors who submit responsive or potentially responsive proposals for the purpose of clarifying aspects of the proposals. However, proposals may be accepted and evaluated without such discussion. Discussions SHALL NOT be initiated by the Offerors.

#### 8. Selection of Finalists

The Evaluation Committee will select and the Procurement Manager, Kathleen Coates will notify the finalist Offerors as per schedule Section II. A., Sequence of Events. A schedule for the oral presentation and demonstration will not be required.

#### 9. Best and Final Offers

Finalist Offerors may be asked to submit revisions to their proposals for the purpose of obtaining best and final offers by as per schedule Section II. A., Sequence of Events

#### **10. Finalize Contractual Agreements**

Any Contractual agreement(s) resulting from this RFP will be finalized with the most advantageous Offeror(s) as per schedule Section II. A., Sequence of Events or as soon thereafter as possible. This date is subject to change at the discretion of the State Purchasing Division or relevant DDPC Procurement office. In the event mutually agreeable terms cannot be reached with the apparent most advantageous Offeror in the time specified, the State reserves the right to finalize a contractual agreement with the next most advantageous Offeror(s) without undertaking a new procurement process.

#### **11. Contract Awards**

After review of the Evaluation Committee Report and the signed contractual agreement, the Agency Procurement Officer, Kathleen Coates will award the contract per the schedule in Section II. A., Sequence of Events. This date is subject to change at the discretion of the DDPC Procurement office.

The contract shall be awarded to the Offeror (or Offerors) whose proposals are most advantageous to the State of New Mexico Developmental Disabilities Planning Council taking into consideration the evaluation factors set forth in this RFP. The most advantageous proposal may or may not have received the most points. The award is subject to appropriate Department and State approval.

#### **12. Protest Deadline**

Any protest by an Offeror must be timely and in conformance with NMSA 1978, § 13-1-172 and applicable procurement regulations. As Kathleen Coates has been named in this Request for Proposals, pursuant to NMSA 1978, § 13-1-172, ONLY protests delivered directly to the Protest Manager, Kathleen Coates in writing and in a timely fashion will be considered to have been submitted properly and in accordance with statute, rule and this Request for Proposals. The 15 calendar day protest period shall begin on the day following the award of contracts and will end at 5:00 pm Mountain Standard Time/Daylight Time on the 15<sup>th</sup> day. Protests must be written and must include the name and address of the protestor and the request for proposal number. It must also contain a statement of the grounds for protest including appropriate supporting exhibits and it must specify the ruling requested from the party listed below. Protests received after the deadline will not be accepted.

# C. GENERAL REQUIREMENTS

#### 1. Acceptance of Conditions Governing the Procurement

Potential Offerors must indicate their acceptance of the Conditions Governing the Procurement section in the letter of transmittal. Submission of a proposal constitutes acceptance of the Evaluation Factors contained in Section V of this RFP.

#### 2. Incurring Cost

Any cost incurred by the potential Offeror in preparation, transmittal, and/or presentation of any proposal or material submitted in response to this RFP shall be borne solely by the Offeror. Any cost incurred by the Offeror for set up and demonstration of the proposed equipment and/or system shall be borne solely by the Offeror.

#### 3. Prime Contractor Responsibility

Any contractual agreement that may result from this RFP shall specify that the prime contractor is solely responsible for fulfillment of all requirements of the contractual agreement with a state agency which may derive from this RFP. The state agency, DDPC entering into a contractual agreement with a vendor will make payments to only the prime contractor.

#### 4. Subcontractors/Consent

The use of subcontractors is allowed. The prime contractor shall be wholly responsible for the entire performance of the contractual agreement whether or not subcontractors are used. Additionally, the prime contractor must receive approval, in writing, from DDPC awarding any resultant contract, before any subcontractor is used during the term of this agreement.

#### 5. Amended Proposals

An Offeror may submit an amended proposal before the deadline for receipt of proposals. Such amended proposals must be complete replacements for a previously submitted proposal and must be clearly identified as such in the transmittal letter. The DDPC personnel will not merge, collate, or assemble proposal materials.

#### 6. Offeror's Rights to Withdraw Proposal

Offerors will be allowed to withdraw their proposals at any time prior to the deadline for receipt of proposals. The Offeror must submit a written withdrawal request addressed to the Procurement Manager, Kathleen Coates and signed by the Offeror's duly authorized representative.

The approval or denial of withdrawal requests received after the deadline for receipt of the proposals is governed by the applicable procurement regulations.

#### 7. Proposal Offer Firm

Responses to this RFP, including proposal prices for services, will be considered firm for one hundred twenty (120) days after the due date for receipt of proposals or ninety (90) days after the due date for the receipt of a best and final offer, if the Offeror is invited or required to submit one.

#### 8. Disclosure of Proposal Contents

- A. Proposals will be kept confidential until negotiations and the award are completed by the DDPC. At that time, all proposals and documents pertaining to the proposals will be open to the public, except for material that is clearly marked proprietary or confidential. The Procurement Manager, Kathleen Coates will not disclose or make public any pages of a proposal on which the potential Offeror has stamped or imprinted "proprietary" or "confidential" subject to the following requirements:
- B. Proprietary or confidential data shall be readily separable from the proposal in order to facilitate eventual public inspection of the non-confidential portion of the proposal.
- C. Confidential data is restricted to:
  - 1. confidential financial information concerning the Offeror's organization;
  - 2. and data that qualifies as a trade secret in accordance with the Uniform Trade Secrets Act, NMSA 1978 § 57-3A-1 to 57-3A-7.
  - 3. PLEASE NOTE: The price of products offered or the cost of services proposed **shall not be designated** as proprietary or confidential information.

If a request is received for disclosure of data for which an Offeror has made a written request for confidentiality, the DDPC shall examine the Offeror's request and make a written determination that specifies which portions of the proposal should be disclosed. Unless the Offeror takes legal action to prevent the disclosure, the proposal will be so disclosed. The proposal shall be open to public inspection subject to any continuing prohibition on the disclosure of confidential data.

#### 9. No Obligation

This RFP in no manner obligates the State of New Mexico or any of its Agencies to the use of any Offeror's services until a valid written contract is awarded and approved by appropriate authorities.

#### 10. Termination

This RFP may be canceled at any time and any and all proposals may be rejected in whole or in part when DDPC determines such action to be in the best interest of the State of New Mexico.

#### **11. Sufficient Appropriation**

Any contract awarded as a result of this RFP process may be terminated if sufficient appropriations or authorizations do not exist. Such terminations will be effected by sending written notice to the contractor. The DDPC's decision as to whether sufficient appropriations and authorizations are available will be accepted by the contractor as final.

#### 12. Legal Review

The DDPC requires that all Offerors agree to be bound by the General Requirements contained in this RFP. Any Offeror's concerns must be promptly submitted in writing to the attention of the Procurement Manager.

#### 13. Governing Law

This RFP and any agreement with an Offeror which may result from this procurement shall be governed by the laws of the State of New Mexico.

#### 14. Basis for Proposal

Only information supplied, in writing, by the DDPC through the Procurement Manager, Kathleen Coates or in this RFP should be used as the basis for the preparation of Offeror proposals.

#### **15. Contract Terms and Conditions**

The contract between DDPC and a contractor will follow the format specified by the DDPC and contain the terms and conditions set forth in the Sample Contract Appendix C. However, the DDPC reserves the right to negotiate provisions in addition to those contained in this RFP (Sample Contract) with any Offeror. The contents of this RFP, as revised and/or supplemented, and the successful Offeror's proposal will be incorporated into and become part of any resultant contract.

The DDPC discourages exceptions from the contract terms and conditions as set forth in the RFP Sample Contract. Such exceptions may cause a proposal to be rejected as nonresponsive when, in the sole judgment of DDPC (and its evaluation team), the proposal appears to be conditioned on the exception, or correction of what is deemed to be a deficiency, or an unacceptable exception is proposed which would require a substantial proposal rewrite to correct.

Should an Offeror object to any of the terms and conditions as set forth in the RFP Sample Contract (APPENDIX C) strongly enough to propose alternate terms and conditions in spite of the above, the Offeror must propose **specific** alternative language. The DDPC may or may not accept the alternative language. General references to the Offeror's terms and

conditions or attempts at complete substitutions of the Sample Contract are not acceptable to the Agency and will result in disqualification of the Offeror's proposal.

Offerors must provide a brief discussion of the purpose and impact, if any, of each proposed change followed by the specific proposed alternate wording.

If an Offeror fails to propose any alternate terms and conditions during the procurement process (the RFP process prior to selection as successful Offeror), no proposed alternate terms and conditions will be considered later during the negotiation process. Failure to propose alternate terms and conditions during the procurement process (the RFP process prior to selection as successful Offeror) is an **explicit agreement** by the Offeror that the contractual terms and conditions contained herein are **accepted** by the Offeror.

#### 16. Offeror's Terms and Conditions

Offerors must submit with the proposal a complete set of any additional terms and conditions they expect to have included in a contract negotiated with DDPC. Please see Section II.C.15 for requirements.

#### **17. Contract Deviations**

Any additional terms and conditions, which may be the subject of negotiation (such terms and conditions having been proposed during the procurement process, that is, the RFP process prior to selection as successful Offeror), will be discussed only between DDPC and the Offeror selected and shall not be deemed an opportunity to amend the Offeror's proposal.

#### **18. Offeror Qualifications**

The Evaluation Committee may make such investigations as necessary to determine the ability of the potential Offeror to adhere to the requirements specified within this RFP. The Evaluation Committee will reject the proposal of any potential Offeror who is not a Responsible Offeror or fails to submit a responsive offer as defined in NMSA 1978, § 13-1-83 and 13-1-85.

#### **19. Right to Waive Minor Irregularities**

The Evaluation Committee reserves the right to waive minor irregularities. The Evaluation Committee also reserves the right to waive mandatory requirements provided that all of the otherwise responsive proposals failed to meet the same mandatory requirements and the failure to do so does not otherwise materially affect the procurement. This right is at the sole discretion of the Evaluation Committee.

#### 20. Change in Contractor Representatives

DDPC reserves the right to require a change in contractor representatives if the assigned representative(s) is not, in the opinion of DDPC, adequately meeting the needs of the Agency.

#### 21. Notice of Penalties

The Procurement Code, NMSA 1978, § 13-1-28 through 13-1-199, imposes civil, misdemeanor and felony criminal penalties for its violation. In addition, the New Mexico criminal statutes impose felony penalties for bribes, gratuities and kickbacks.

#### 22. Agency Rights

The DDPC in agreement with the Evaluation Committee reserves the right to accept all or a portion of a potential Offeror's proposal.

#### 23. Right to Publish

Throughout the duration of this procurement process and contract term, Offerors and contractors must secure from the agency written approval prior to the release of any information that pertains to the potential work or activities covered by this procurement and/or agency contracts deriving from this procurement. Failure to adhere to this requirement may result in disqualification of the Offeror's proposal or removal from the contract.

#### 24. Ownership of Proposals

All documents submitted in response to the RFP shall become property of the State of New Mexico DDPC.

#### 25. Confidentiality

Any confidential information provided to, or developed by, the contractor in the performance of the contract resulting from this RFP shall be kept confidential and shall not be made available to any individual or organization by the contractor without the prior written approval of the DDPC.

The Contractor(s) agrees to protect the confidentiality of all confidential information and not to publish or disclose such information to any third party without the procuring Agency's written permission.

#### 26. Electronic mail address required

A large part of the communication regarding this procurement will be conducted by electronic mail (e-mail). Offeror must have a valid e-mail address to receive this correspondence. (See also Section II.B.5, Response to Written Questions).

#### 27. Use of Electronic Versions of this RFP

This RFP is being made available by electronic means. In the event of conflict between a version of the RFP in the Offeror's possession and the version maintained by the DDPC, the Offeror acknowledges that the version maintained by the agency shall govern. Please refer to: <u>https://www.generalservices.state.nm.us/statepurchasing/active-procurements.aspx</u>.

#### 28. New Mexico Employees Health Coverage

- A. If the Offeror has, or grows to, six (6) or more employees who work, or who are expected to work, an average of at least 20 hours per week over a six (6) month period during the term of the contract, Offeror must agree to have in place, and agree to maintain for the term of the contract, health insurance for those employees if the expected annual value in the aggregate of any and all contracts between Contractor and the State exceed \$250,000 dollars.
- B. Offeror must agree to maintain a record of the number of employees who have (a) accepted health insurance; (b) decline health insurance due to other health insurance coverage already in place; or (c) decline health insurance for other reasons. These records are subject to review and audit by a representative of the state.
- C. Offeror must agree to advise all employees of the availability of State publicly financed health care coverage programs by providing each employee with, as a minimum, the following web site link to additional information <u>https://www.bewellnm.com.</u>
- D. For Indefinite Quantity, Indefinite Delivery contracts (price agreements without specific limitations on quantity and providing for an indeterminate number of orders to be placed against it); these requirements shall apply the first day of the second month after the Offeror reports combined sales (from state and, if applicable, from local public bodies if from a state price agreement) of \$250,000.

#### 29. Campaign Contribution Disclosure Form

Offeror must complete, sign, and return the Campaign Contribution Disclosure Form, APPENDIX B, as a part of their proposal. This requirement applies regardless whether a covered contribution was made or not made for the positions of Governor and Lieutenant Governor or other identified official. Failure to complete and return the signed unaltered form will result in disqualification.

#### **30. Letter of Transmittal**

Offeror's proposal must be accompanied by the Letter of Transmittal Form located in APPENDIX E which must be completed and signed by an individual person authorized to obligate the company. The letter of transmittal MUST:

- 1. Identify the submitting business entity.
- 2. Identify the name, title, telephone, and e-mail address of the person authorized by the Offeror organization to contractually obligate the business entity providing the Offer.
- 3. Identify the name, title, telephone, and e-mail address of the person authorized to negotiate the contract on behalf of the organization (if different than (2) above).
- 4. Identify the names, titles, telephone, and e-mail addresses of persons to be contacted for clarification/questions regarding proposal content.
- 5. Identify sub-contractors (if any) anticipated to be utilized in the performance of any resultant contract award.
- 6. Describe the relationship with any other entity which will be used in the performance of this awarded contract.
- 7. Identify the following with a check mark and signature where required:
  - a. <u>Explicitly</u> indicate acceptance of the Conditions Governing the Procurement stated in Section II. C.1;
  - b. **Explicitly** indicate acceptance of Section V of this RFP; and
  - c. Acknowledge receipt of any and all amendments to this RFP.
- 8. Be signed by the person identified in para 2 above.

## **31. Disclosure Regarding Responsibility**

- A. Any prospective Contractor and any of its Principals who enter into a contract greater than sixty thousand dollars (\$60,000.00) with any state agency or local public body for professional services, tangible personal property, services or construction agrees to disclose whether the Contractor, or any principal of the Contractor's company:
  - 1. is presently debarred, suspended, proposed for debarment, or declared ineligible for award of contract by any federal entity, state agency or local public body;
  - 2. has within a three-year period preceding this offer, been convicted in a criminal matter or had a civil judgment rendered against them for:
    - a. the commission of fraud or a criminal offense in connection with obtaining, attempting to obtain, or performing a public (federal, state or local) contract or subcontract;
    - b. violation of Federal or state antitrust statutes related to the submission of offers; or
    - c. the commission in any federal or state jurisdiction of embezzlement, theft, forgery, bribery, falsification or destruction of records, making false statements, tax evasion, violation of Federal criminal tax law, or receiving stolen property;
  - 3. is presently indicted for, or otherwise criminally or civilly charged by any (federal state or local) government entity with the commission of any of the offenses enumerated in paragraph A of this disclosure;

- 4. has preceding this offer, been notified of any delinquent Federal or state taxes in an amount that exceeds \$3,000.00 of which the liability remains unsatisfied. Taxes are considered delinquent if the following criteria apply.
  - a. The tax liability is finally determined. The liability is finally determined if it has been assessed. A liability is not finally determined if there is a pending administrative or judicial challenge. In the case of a judicial challenge of the liability, the liability is not finally determined until all judicial appeal rights have been exhausted.
  - b. The taxpayer is delinquent in making payment. A taxpayer is delinquent if the taxpayer has failed to pay the tax liability when full payment was due and required. A taxpayer is not delinquent in cases where enforced collection action is precluded.
  - c. Have within a three year period preceding this offer, had one or more contracts terminated for default by any federal or state agency or local public body.)
- B. Principal, for the purpose of this disclosure, means an officer, director, owner, partner, or a person having primary management or supervisory responsibilities within a business entity or related entities.
- C. The Contractor shall provide immediate written notice to the State Purchasing Agent or other party to this Agreement if, at any time during the term of this Agreement, the Contractor learns that the Contractor's disclosure was at any time erroneous or became erroneous by reason of changed circumstances.
- D. A disclosure that any of the items in this requirement exist will not necessarily result in termination of this Agreement. However, the disclosure will be considered in the determination of the Contractor's responsibility and ability to perform under this Agreement. Failure of the Contractor to furnish a disclosure or provide additional information as requested will render the Offeror nonresponsive.
- E. Nothing contained in the foregoing shall be construed to require establishment of a system of records in order to render, in good faith, the disclosure required by this document. The knowledge and information of a Contractor is not required to exceed that which is the normally possessed by a prudent person in the ordinary course of business dealings.
- F. The disclosure requirement provided is a material representation of fact upon which reliance was placed when making an award and is a continuing material representation of the facts during the term of this Agreement. If during the performance of the contract, the Contractor is indicted for or otherwise criminally or civilly charged by any government entity (federal, state or local) with commission of any offenses named in this document the Contractor must provide immediate written notice to the State Purchasing Agent or other party to this Agreement. If it is later determined that the Contractor knowingly rendered an erroneous disclosure, in addition to other remedies available to the Government, the State Purchasing Agent or Central Purchasing Officer

may terminate the involved contract for cause. Still further the State Purchasing Agent or Central Purchasing Officer may suspend or debar the Contractor from eligibility for future solicitations until such time as the matter is resolved to the satisfaction of the State Purchasing Agent or Central Purchasing Officer.

#### **32. New Mexico Preferences**

To ensure adequate consideration and application of NMSA 1978, § 13-1-21 (as amended), Offerors must include a copy of their preference certificate with their proposal. Certificates for preferences must be obtained through the New Mexico Department of Taxation & Revenue http://www.tax.newmexico.gov/Businesses/in-state-veteran-preference-certification.aspx.

#### A. New Mexico Business Preference

A copy of the certification must accompany your proposal.

#### B. New Mexico Resident Veterans Business Preference

A copy of the certification must accompany your proposal.

An agency shall not award a business both a resident business preference and a resident veteran business preference.

The New Mexico Preferences shall not apply when the expenditures for this RFP includes federal funds.

New Mexico Preferences do not apply as the Developmental Disabilities Planning Council (DDPC) receives Federal Funding.

# **III. RESPONSE FORMAT AND ORGANIZATION**

# A. NUMBER OF RESPONSES

Offerors shall submit only one (1) proposal in response to this RFP.

# **B. NUMBER OF COPIES**

## 1. Hard Copy Responses

Offeror's proposal must be clearly labeled and numbered and indexed as outlined in **Section III.C. Proposal Format**. Proposals must be submitted as outlined below. The original copy shall be clearly marked as such on the front of the binder. Each portion of the proposal (technical/cost) must be submitted in separate binders and must be prominently displayed on the front cover. Envelopes, packages or boxes containing the original and the copies must be clearly labeled and submitted in a sealed envelope, package, or box bearing the following information:

- F. Other Supporting Documentation

Within each section of the proposal, Offerors should address the items in the order indicated above. All forms provided in this RFP must be thoroughly completed and included in the appropriate section of the proposal.

The proposal summary may be included by potential Offerors to provide the Evaluation Committee with an overview of the proposal; however, this material will not be used in the evaluation process unless specifically referenced from other portions of the Offeror's proposal.

Offerors may attach other material that they feel may improve the quality of their responses. However, these materials should be included as items in a separate appendix, under the heading "Other Supporting Documentation". Each item in this section should be noted in the table of contents with corresponding pagination; each item appearing in this section should be preceded by a brief descriptive narrative.

# **IV. SPECIFICATIONS**

Offerors should respond in the form of a thorough narrative to each specification, unless otherwise instructed. The narratives, including required supporting materials will be evaluated and awarded points accordingly.

# A. DETAILED SCOPE OF WORK

#### Scope of Work.

The Contractor shall perform the following work

A. <u>Services</u>. When assigned by Agency and appointed by a state district court, Contractor shall provide guardianship services to New Mexico residents who are at least eighteen (18) years old, qualify for Agency services, are financially eligible for Medicaid or a similar public benefit and have been adjudicated as incapacitated.

#### B. <u>Definitions</u>:

- (1) "Alleged Incapacitated Person" means an adult New Mexican alleged to be incapacitated who is financially eligible for Office of Guardianship legal services;
- (2) "Contractor" means the entity or individual contracting with Agency to provide guardianship services pursuant to this Agreement. Contractor shall be the "guardian of last resort" where no family member or other qualified person is willing, suitable or able to serve as guardian of the Protected Person;
- (3) "Court Visitor" means a person who is an appointee of a State district court who has no personal interest in the proceeding and who has been trained or has the expertise to appropriately evaluate the needs of the Alleged Incapacitated Person. A Court Visitor may include, but is not limited to, a psychologist, social worker, developmental incapacity professional, physical or occupational therapist, an educator and a rehabilitation worker (NMSA 1978, § 45-5-101(V));
- (4) "Agent" means an entity or individual whom the Executive Director has approved to represent or act on behalf of the Agency;
- (5) "GAL" means guardian ad litem: The attorney appointed by a State district court to represent and protect the interests of an Alleged Incapacitated Person in connection with an adult guardianship court proceeding (NMSA 1978, § 45-1-201(A)(22));
- (6) "Guardianship Coordinator" means the individual who has passed the Center for Guardianship Certification exam, is currently certified to work with Protected Persons, and serves the Protected Person as an employee or independent contractor of Contractor. If Contractor does not employ or contract with individual Guardianship Coordinators, then "Contractor" and "Guardianship Coordinator" are one and the same.
- (7) "Office of Guardianship" means Agency's statutory program that contracts for the provision of probate code guardianship services to income-eligible adult New Mexicans needing a guardian;

- (8) "PET" means petitioning attorney: The attorney who petitions a State District Court for appointment of a guardian for an Alleged Incapacitated Person;
- (9) "Proposed Guardian" means the entity or individual assigned by the Office of Guardianship to provide a Protected Person with guardianship services as described by this Agreement; and
- (10) "Protected Person" means an adult New Mexican for whom a guardian has been appointed by a State district court in legal proceedings.

**C.** <u>Least Restrictive Standards</u>. Consistent with the court order appointing Contractor as Guardian, and adhering to the least restrictive standards of service, Contractor is responsible for decision-making in Protected Person's major life areas as authorized by the court order.

**D.** <u>Guardianship Practices</u>. Guardianship services shall be provided in accordance with the terms of this Agreement and the following legal authority and guardianship practices, including but not limited to the:

- (1) Uniform Probate Code (NMSA 1978, §§ 45-5-101 to -315);
- (2) Office of Guardianship Act (NMSA 1978, §§ 28-16B-1 to -6);
- (3) Uniform Health-Care Decisions Act (NMSA 1978, §§ 24-7A-1 to -18);
- (4) Mental Health Care Treatment Decisions Act (NMSA 1978, §§ 24-7B-1 to -6);
- (5) Adult Protective Services Act (NMSA 1978, §§ 27-7-1 to -31);
- (6) Rule of the Office of Guardianship (9.4.21 NMAC); and
- (7) National Guardianship Association (NGA): Standards of Practice; Ethical Principles for Guardians; and Standards for Agencies and Programs Providing Guardianship Services.

#### E. <u>Certification and Criminal History Screening Requirements</u>.

- (1) Before contracting with Agency, Contractor shall successfully obtain certification through the Center for Guardianship Certification (CGC) or shall disclose non-certification to Agency. Contractor is responsible for all costs associated with CGC certification.
- (2) Contractor shall employ or contract with Guardianship Coordinators who possess certification through the CGC. Contractor shall ensure that each of their Guardianship Coordinators is certified within ninety (90) calendar days of being assigned the duties of guardian. Contractor shall provide Agency with copies of CGC certification for all such employees and contractors within thirty (30) calendar days of their certification.
- (3) Within ten (10) calendar days after hiring or contracting with a Guardianship Coordinator, Contractor shall provide Agency with: (a) the employee or contractor's name and date of hire or contract, and (b) a color photograph of and contact information (including telephone number and email address) for each Guardianship Coordinator. Contractor shall update such contact information within five (5) business days of learning of the change. Agency shall have full authority to communicate with any Guardianship Coordinator regarding Contractor and Contractor's Protected Persons.

- (4) Contractor shall not allow non-CGC certified staff to make any decisions on behalf of a Protected Person. Contractor shall only assign Protected Person cases to certified Guardianship Coordinators.
- (5) Contractor and its Guardianship Coordinators shall maintain their CGC certifications throughout the term of this Agreement. Contractor shall immediately notify Agency if any CGC certification lapses, and shall re-obtain certification within thirty (30) calendar days. A Contractor or Guardianship Coordinator who has allowed its CGC certification to lapse shall not provide direct guardianship services to any Protected Persons served pursuant to this Agreement. Contractor shall be responsible for all fees and costs associated with any guardianship transfers made necessary by a lapse in CGC certification.
- (6) Contractor and its Guardianship Coordinators shall comply with the Caregivers Criminal History Screening Act (NMSA 1978, § 29-17-5) and Screening Requirements (7.1.9 NMAC). No Guardianship Coordinator shall perform any direct guardianship services under this Agreement until they have received a Notification of Clearance from the New Mexico Department of Health that specifically names Contractor as the facility that referred the applicant. Contractor shall provide Agency with the Notification of Clearance for each Guardianship Coordinator within five (5) calendar days of receipt. Contractor shall not employ or contract with any person who has been excluded from the Medicare or Medicaid Programs.
- (7) If Contractor fails to comply with any of the terms of this Paragraph, Agency may terminate the Agreement and, at Contractor's sole expense, transfer its appointed guardianships to other qualified guardians.

**F.** <u>Caseload</u>. Only certified Guardianship Coordinators shall carry a case load. Guardianship Coordinators shall not carry a caseload of more than thirty (30) Protected Persons. In rare circumstances, Agency may agree to an exception for an increased caseload.

G. <u>Partnership with Protected Person</u>. Contractor shall ensure that:

- (1) A Protected Person receiving services is, to the highest degree possible, involved in individual planning, decision-making, implementation and evaluation of those services; and
- (2) All services provided are designed to enhance, promote and expand independence, self-sufficiency, self-esteem and quality of life of a Protected Person.
- (3) The Guardianship Coordinator shall have at least one in-person, individual face-toface visit per month with each Protected Person.

**H.** <u>Protected Person's Civil Rights</u>. A Protected Person for whom guardian has been appointed retains all legal and civil rights except those that have been expressly limited by court order.

Contractor shall notify Protected Person annually of their civil rights in a language and communication style that they best understand. The Protected Person, or someone, other

than the Contractor or Guardian Coordinator, who knows them well, must acknowledge in writing annually that the Contractor reviewed the Protected Person's civil rights with them.

Contractor shall ensure that these rights are protected. These rights include, but are not limited to, the following:

- (1) The right to be free from unlawful discrimination, including age, disability, ethnicity, gender, marital status, national origin, race, religion, and sexual orientation;
- (2) The right to be treated humanely, with dignity and respect, and be protected against emotional or psychological abuse, physical abuse, sexual abuse, neglect and exploitation;
- (3) The right to be served in the most integrated setting appropriate to Protected Person's needs;
- (4) The right to practice the religion of their choice, or abstain from the practice of religion;
- (5) The right to receive visitors and communicate with others;
- (6) The right to privacy;
- (7) The right to participate in the political process, including the right to vote in accordance with NMSA 1978, § 45-5-109;
- (8) The right to voice grievances and complaints without interference, coercion, or reprisal;
- (9) The right to counsel and access to available advocacy services;
- (10) The right to have access to the courts;
- (11) The right to receive services to which they are entitled;
- (12) The right to be restored to capacity at the earliest possible time;
- (13) The right to have review of the need for restriction of rights;
- (14) The right to have a qualified guardian;
- (15) The right to remain as independent as possible;
- (16) The right to determine their place of residency, or have their preference honored;
- (17) The right to own, use, and control their property, or have their property managed prudently and have timely information about how their property is being managed;
- (18) The right to consent to or refuse medical treatment, unless that authority has been granted to a guardian, or if a treatment guardian has been appointed to make mental health treatment decisions pursuant to the Mental Health and Developmental Disabilities Code (NMSA 1978, § 43-1-15);
- (19) The right to seek or retain employment;
- (20) The right to travel; and
- (21) The right to notice and to attend all proceedings relating to their capacity.

**I.** <u>**Person-Centered Plan.**</u> Contractor shall prepare and maintain a plan consistent with NGA standards. When applicable, Contractor shall participate in, and coordinate with, Protected Person's Individual Service Plan or Interdisciplinary Team, consistent with NGA Standards of Practice. The Contractor's case file for the Protected Person shall contain a person-centered plan developed in conjunction with the Protected Person, their guardian, and their service provider(s), if any. The plan shall reflect the goals and preferences of the Protected Person and shall address all of their needs, including medical and psychiatric

care, residential needs, financial issues, and other needs specific to each Protected Person. The plan shall be updated at least annually.

J. <u>Case File Management</u>. Contractor shall maintain current, complete and comprehensive case files on each Protected Person that contain only those items pertaining to the services provided. All Protected Person's paper case files shall be segregated in a locked cabinet or locked file room and securely stored so as to protect the privacy of the Protected Person and deny access by unauthorized persons. All digital files pertaining to a Protected Person shall be secured so as to protect the privacy of the Protected Person shall be secured so as to protect the privacy of the Protected Person shall be secured as a required item is not applicable or unable to be obtained, written reasons shall be prepared and placed in Protected Person's file. The case file shall contain a table of contents listing each required item.

Each Protected Person's case file shall include all the specific information and documents set forth in National Guardianship Association (NGA) Standard of Practice 13.III.A - M (*Client file*), and the following additional information and documents:

- (1) Current background information form or coversheet for Protected Person that includes the Protected Person's name, date of birth, address, telephone number, Social Security number, medical coverage, health care providers, diagnoses, medications and allergies to medications, assigned Guardianship Coordinator and contact information, type of residence, and their contact information, two names and addresses of next of kin, if available;
- (2) Protected Person's birth certificate and Social Security card;
- (3) Sign-in sheet showing the name and date of anyone other than the Contractor's staff that has accessed the file;
- (4) Financial eligibility information, including as applicable, current income, Medicaid eligibility and trusts;
- (5) Contractor's internal complaint procedures form reviewed and signed annually by the Protected Person or someone who knows them well, which cannot be the Contractor or Guardianship Coordinator;
- (6) All documents relating to reports of incidents and records of all incident investigations against the Contractor, their Guardian Coordinator, or involving their Protected Person, including findings and outcomes;
- (7) Correspondence relating to Protected Person;
- (8) All court-endorsed pleadings, orders, and annual reports; and
- (9) Quarterly financial statements of the Protected Person when Contractor has financial authority granted in their guardianship order.

#### K. Finances of the Protected Person and Financial Ledgers.

- (1) In every case where Contractor has financial authority of a Protected Person in their guardianship order, Contractor shall monitor the Protected Person's finances for exploitation, misuse, and fraud. Contractor shall develop and maintain written internal policies and procedures governing how the Contractor manages or monitors a Protected Person's funds. Contractor shall ensure all staff are trained on these policies and procedures;
- (2) Contractors with financial authority in their guardianship order must maintain quarterly

financial statements regarding the Protected Person. For Contractors with financial authority but the Social Security Administration has appointed a Representative Payee other than Contractor, quarterly financial statements generated by the Representative Payee are required in each file. If Contractor is unable to obtain quarterly financial statements from a Representative Payee, Contractor shall document their attempts and report the Representative Payee's lack of cooperation to the Social Security Administration.

- (3) Contractor shall maintain separate financial accounts and detailed ledgers for each Protected Person for whom the Contractor or Guardianship Coordinator makes any financial decision or transaction;
- (4) Contractor shall maintain and monitor quarterly financial reports showing the beginning balance of each Protected Person's financial account, line items for incoming revenue and outgoing expenses, and an ending balance;
- (5) Contractor shall submit to Agency all requested financial reports within three (3) business days of Agency making such request.

#### L. Contractor's Records.

- (1) Contractor shall maintain detailed records of each Protected Person's visit, specifying the date, amount of time (in quarter hour increments), nature of all services rendered, and identification of the person(s) providing the services. Documentation shall include signature of the Guardian Coordinator and the Protected Person or someone, other than the Contractor or Guardian Coordinator, who knows them well Contractor shall maintain these records for a period of seven (7) years from the date of final payment under this Agreement.
- (2) All billing and case file records shall be subject to immediate inspection and copying by Agency or its agents, the Department of Finance and Administration (DFA), and the State Auditor. Agency shall have the right to audit all billings and monthly reports both before, and for seven (7) years after payment is made. Payment pursuant to this Agreement shall not foreclose Agency's right to recover any excessive, illegal, or improper payments made to Contractor.

**M.** <u>**Complaint Procedures.**</u> Contractor shall establish and implement internal written procedures available to all Protected Persons to present complaints relating to Contractor's services. Complaint procedures shall comply with the rules of the Office of Guardianship, 9.4.21.14 NMAC, *Complaints Against Contractors* and shall include, at a minimum, the following:

- (1) Contractor shall notify Protected Person of the complaint procedures annually in a language and communication style that they best understand. The Protected Person or their representative must acknowledge that the Contractor reviewed its internal written complaint procedures;
- (2) Within thirty (30) calendar days after receipt of the complaint, Contractor shall:
  - (a) Meet in person with Protected Person and, if applicable, their representative, and attempt to reach a written resolution;
  - (b) Document in writing the resolution or non-resolution of the complaint, signed and dated by all parties to the attempted resolution;
  - (c) Explain the complaint resolution to Protected Person and document this explanation, including date, time, and person communicating with Protected Person; and

- (d) Provide the written complaint resolution to Protected Person and, if applicable, their representative, and maintain a copy in Protected Person's case file.
- (3) Contractor shall forward to Agency either the:
  - (a) Written complaint resolution within five (5) business days, or
  - (b) Unresolved complaint within two (2) business days after the thirty (30) day deadline for complaint resolution; and

(4) If the complaint cannot be resolved with Contractor, Protected Person or their representative may submit the written complaint to the Office of Guardianship, with a copy given to Contractor.

**N.** <u>Incident Reporting</u>. Within five (5) business days of learning of an allegation, Contractor shall provide Agency, in writing, the following information regarding any allegations of abuse, neglect, or exploitation made against Contractor in regard to a Protected Person:

- (1) When received by Contractor, copies of all documents received from Department of Health's Division of Health Improvement (DHI) and Aging and Long-Term Services Department's Adult Protective Services (APS); and
- (2) Copies of all complaints, reports, and correspondence made to DHI Licensing and Certification, APS, or Attorney General's Medicaid Fraud and Elder Abuse Division involving the Protected Person.

**O.** <u>Insurance</u>. Contractors with a contract of \$60,000 or less in compensation shall obtain and maintain professional liability insurance in an amount no less than \$500,000 per occurrence and \$1 million in the aggregate. Contractors with a contract over \$60,000 in compensation shall obtain and maintain professional liability insurance in an amount no less than \$1 million per occurrence and \$3 million in the aggregate. Insurance shall cover acts of misconduct, violations of fiduciary duties, and civil and criminal misconduct by Contractor, its Guardianship Coordinators, and its employees and subcontractors. Insurance shall be obtained through a company licensed to do business in New Mexico and in good standing. The State of New Mexico Developmental Disabilities Planning Council shall be identified as an Additional Insured. Contractor shall disclose, in writing, proof of professional liability insurance coverage and the amount of coverage within thirty (30) days after the effective date of this Agreement. The policy shall require that Agency is immediately notified by the insurance company, in writing, if insurance coverage lapses or is terminated.

**P.** <u>Fidelity/Dishonesty Bond</u>. Contractor shall obtain and maintain a fidelity or dishonesty bond covering each person who administers or authorizes payment of Protected Person funds or those monies received pursuant to this Agreement. Contractor shall disclose, in writing, proof and the amount of this fidelity or dishonesty bond within thirty (30) days after the effective date of this Agreement. The policy shall require that Agency is immediately notified by the insurance company, in writing, if insurance coverage lapses or is terminated.

(1) The fidelity bond shall provide for indemnification of losses occasioned by (a) any fraudulent or dishonest act or acts committed by any of Contractor's employees or agents acting alone or in collusion, and (b) the failure of Contractor or its employees or agents to perform faithfully any duty or properly account for all monies and property received or entrusted by Contractor.

- (2) If the total amount of this Agreement is less than One Hundred Thousand Dollars (\$100,000) per year, the minimum fidelity bond shall be Ten Thousand Dollars (\$10,000). If the total Agreement amount is more than One Hundred Thousand Dollars (\$100,000) per year, the fidelity bond shall be in an amount equal to twenty-five percent (25%) of the total Agreement amount. The fidelity bond shall remain in effect for the term of this Agreement plus thirty (30) days.
- (3) The fidelity bond shall include third-party coverage for the property of Protected Persons. In the event Contractor cannot obtain a third-party fidelity bond, Agency reserves the right to require a financial guarantee surety bond naming Agency as Obligee and in an amount to be determined. Agency may waive either of these bond requirements. If Contractor is a sole proprietorship or partnership, the proprietor or partners shall be considered employees or agents under the terms of the fidelity bond. The State of New Mexico Developmental Disabilities Planning Council shall be named as Loss Payee.

**Q.** <u>Notice of Death, Serious Injury or Elopement</u>. Contractor shall provide written notice to Agency of the following actions, as specifically prescribed below, and, as applicable, shall immediately provide Agency with copies of all filed and/or endorsed documents:

- (1) Within seventy-two (72) hours after learning of the death of a Protected Person. Within thirty (30) calendar days after the death, Contractor shall provide Agency a copy of the court-endorsed Final Report of Guardian;
- (2) Within twenty-four (24) hours after learning of any life-threatening or serious injury sustained by a Protected Person;
- (3) Within seventy-two (72) hours after learning of a Protected Person missing or eloping from their residence. Contractor shall also (a) file a missing person's report with a law enforcement agency in the Protected Person's last known county of residence, and (b) file a Notice of Elopement with the court.
- **R.** <u>Notice of Changes</u>. Contractor shall immediately notify Agency in writing:
  - (1) Of any change in Protected Person's contact information;
  - (2) Of any change in Contractor's contact information;
  - (3) Of any change in the level of assets or resources that may make Protected Person ineligible for Medicaid or a similar public benefit, and thus ineligible for State-funded guardianship services, within thirty (30) calendar days after Contractor receives such information;
  - (4) If it learns that another person may be willing, suitable and able to serve as the guardian of Protected Person, so that Agency may determine if a transfer of guardianship is appropriate; and
  - (5) If Protected Person appears to have made gains in their capacity or be in need of increased protection such that a court's review of the guardianship is indicated. Contractor shall then act in accordance with 9.4.21.18 NMAC, *Comprehensive Evaluations*.

**S.** <u>Resignation and Termination as Guardian; Transfer to Successor Guardian</u>. To ensure continuity of care for Protected Persons served pursuant to this Agreement.

 If Contractor wishes to resign or terminate serving as a court-appointed guardian for Protected Person (for any reason other than Protected Person's death), Contractor shall provide advance written notice to Agency of its desire to resign at least 90 days prior to resignation and provide detailed reasons for so doing.

- (2) If Contractor wishes to transfer guardianship of Protected Person to a successor guardian, Contractor shall provide at least thirty (30) days advance written notice to Agency of its desire to transfer, and provide detailed reasons for so doing. Unless Agency determines good cause exists to transfer guardianship, Contractor is liable for the legal expenses necessary to transfer the guardianship.
- (3) Contractor shall comply with all Agency requirements regarding transfers and reassignments.
- (4) For any resignation, termination, or transfer of guardianship proceeding, Contractor shall name Agency as an Interested Person and provide notice to Agency of all legal proceedings, including court hearings and status conferences.
- (5) If appropriate, Agency shall assign a successor guardian and shall make reasonable efforts to have a successor guardian appointed by the court. Contractor shall **not** itself arrange for a particular person to be appointed as successor guardian.
- (6) Contractor shall continue to serve as the court-appointed guardian until the court orders otherwise or appoints a successor guardian.

**T.** <u>Audits</u>. The Agency may utilize outside contractors, including certified public accountants, to audit Contractor's (1) billings related to Medicaid; (2) services funded pursuant to this Agreement; and (3) management of the Protected Person's financial affairs, if applicable. Agency shall provide Contractor at least two (2) weeks advance written notice of such an audit. Contractor shall cooperate fully with Agency and outside contractors acting as agents of the Agency.

## U. Access to Records.

- (1) Agency shall have access to the Protected Person's case records, including but not limited to: copies of court filings and reports, financial records, and all other records maintained by the Contractor related to contracted services provided and the scope of the court orders, unless specifically sequestered by the courts.
- (2) When requested, or during Agency's visit with Protected Person, Contractor shall immediately produce all records and files of Protected Person.
  - (a) If Contractor cannot produce the records immediately, it shall produce those records on or before the close of business the day after the request.
  - (b) Contractor's failure or refusal, without good cause shown, to timely produce the records shall constitute a breach of this Agreement and Agency may deny payment to Contractor for that Protected Person for the month(s) the records are not timely produced.
- (3) When transferring guardianship to a successor guardian, Contractor shall transmit the contents of the original Protected Person's case file and an inventory list of personal property of Protected Person to the successor guardian at the court hearing on the transfer.
  - (a) If the transfer is ordered without a hearing, Contractor shall transmit this client case file and the Protected Person's personal property to the successor guardian within twenty-four (24) hours after entry of a court order.
  - (b) Contractor's failure or refusal, without good cause shown, to timely transfer the complete client case file shall constitute a breach of this Agreement and

Agency may impose any sanction it deems appropriate and may deny payment to Contractor for that Protected Person for the month(s) the records are not timely transferred.

**V.** <u>Monitoring Review</u>. Agency may periodically conduct reviews to ensure the delivery of quality services consistent with this Agreement. Contractor shall fully comply with the requirements of any services review of an account, inventory, or property of the Protected Person. This services review includes, but is not limited to, an examination of the following:

- (1) Protected Persons are living in conditions that are least restrictive, promote independence and autonomy, and are appropriate to their needs;
- (2) Contractor establishes and implements an adequate internal complaint procedure, available to all Protected Persons;
- (3) Protected Person's civil and legal rights are adequately safeguarded;
- (4) Staff is qualified by education, training, and experience to perform the duties of guardian;

(5) Contractor adopts and implements policies and procedures that are consistent with the NGA Standards of Practice, NGA Ethical Principles for Guardians, and NGA Standards for Agencies and Programs Providing Guardianship Services;

- (6) Contractor complies with all terms and conditions of this Agreement;
- (7) Contractor maintains insurance and bonding requirements;
- (8) Contractor maintains all billing and accounting records related to the Protected Person;
- (9) Termination of Protected Person's services is appropriate under the circumstances;
- (10) All Guardianship Coordinators shall be available for any Agency onsite visit or comprehensive services review;
- (11) All court-endorsed pleadings and reports; and
- (12) Services in accordance with this Agreement and within in the scope of the order granted by the courts.

W. <u>Mandatory Annual Contractors Meeting</u>. There shall be an annual Contractors meeting that Contractors must attend. Contractor and its Guardianship Coordinators must know and comply with all information presented at this meeting. Agency will notify Contractor at least sixty (60) days in advance of the meeting date, time and location.

## X. Corrective Action Plan/Sanctions.

If Agency determines that Contractor failed to comply with any terms of this Agreement, statutory obligation, or court order, or fails to timely address a Protected Person's needs or grievances, Agency may provide Contractor with a *Written Notification of Deficiencies* and may require Contractor to develop and submit to Agency a proposed *Corrective Action Plan (CAP)* that timely addresses and resolves these deficiencies.

If required by Agency, Contractor shall develop and submit to Agency a proposed *CAP* within thirty (30) business days after receipt of the *Written Notification of Deficiencies*. If necessary, Contractor may request additional time to submit their proposed *CAP*, but Agency reserves the right to decline an extension.

The *CAP* shall include, at a minimum:

- (a) Identification of the deficiencies;
- (b) Specific corrective action steps Contractor shall take to resolve the deficiencies;
- (c) Timeframe necessary to complete each corrective action step;
- (d) Anticipated date of completion of *CAP*; and
- (e) Names of the persons responsible for each corrective action step.

Agency shall provide Contractor a written acceptance or rejection of the proposed *CAP* within fifteen (15) business days of receiving the proposed *CAP* from Contractor.

When all identified deficiencies are resolved to the Agency's satisfaction, Agency shall provide Contractor with a Statement of Compliance.

If Contractor cannot resolve the identified deficiencies to Agency's satisfaction within 120 days after the date of the Agency-approved *CAP*, Agency has the right to:

- (a) Take such other actions as it deems appropriate
- (b) Withhold payment from Contractor
  - a. Thirty (30) days after Contractor's receipt of the *Written Notification of Deficiencies*, Agency shall withhold from Contractor's total monthly contract payment: (a) 15% of Contractor's total monthly contractual payment for the first month of noncompliance, and (b) 20% for the second month of noncompliance.
  - b. Agency's withholding of payment for any given month shall remain in effect even if Contractor comes into compliance during that month.
  - c. Upon Agency's written *Statement of Compliance*, Agency shall resume contract payments.
- (c) Seek damages and attorney fees from Contractor for transferring guardianship to another guardian;
- (d) Seek reimbursement from Contractor for Agency costs incurred as a result of contract non-compliance;
- (e) File a claim with Contractor's insurance and bond providers;
- (f) Terminate this Agreement; and
- (g) Seek further redress through State and Federal law.

**Y.** <u>Conflict of Interest</u>. No Contractor shall serve on the board of directors of another service provider contracted by Agency. No state employee whose job functions have a direct impact on the Office of Guardianship shall serve on Contractor's board of directors. Contractor shall avoid serving on an assigned guardianship case if their spouse, significant other, immediate family member, business partner or employer is also assigned to the same case.

**Z.** <u>Prompt Communication</u>. Contractor shall, without exception or excuse, respond to any and all Office of Guardianship and PET communications within forty-eight (48) hours.

**AA.** <u>Invoicing</u>. Contractor shall invoice for services provided to eligible Protected Persons who have received court-appointed guardianship services through the Office of Guardianship. Contractor shall submit invoices to Agency's Contract Specialist by the 5<sup>th</sup> day of the month for the previous billing month's services. Invoices received after this date may have payment delayed.

All invoices must be approved by Agency. Agency shall process approved invoices for payment and submit to DFA for approval, so long as Contractor is in compliance with all terms and requirements of this Agreement.

In order to receive payment, each monthly face-to-face visit must be documented by the dated signatures of both the Guardianship Coordinator and the Protected Person or someone who knows them well, other than Contractor or the Guardian Coordinator.

Contractor shall obtain written assignment as guardian from Agency in order to invoice and be paid by Agency for guardianship services:

- (1) If Adult Protective Services or a court requests Contractor to serve as guardian, before Contractor accepts such appointment, Contractor must request and receive written assignment from Agency in order to be paid by Agency.
- (2) Contractor may select a Guardianship Coordinator to serve Protected Person, but shall consider Agency's criteria and the best interests of Protected Person (e.g., Protected Person needs a guardian of a specific gender or background).
- (3) Agency has the sole discretion to determine assignments.

**BB.** <u>Medicaid Reporting</u>. - (vii) The Guardianship Coordinator's written affirmation as to the Worksheet's accuracy, and signed and dated.
- (5) Agency will generate a Consolidated Data Sheet and provide it to Participating Contractor for its review. Participating Contractor shall attest to the accuracy of the Consolidated Data Sheet by its signature, title, telephone number and date signed, in blue ink.
- (6) Agency will provide technical assistance and consultation, as needed, to Participating Contractor on the requirements for its participation in the reporting and administrative claiming of guardianship services for recipients of New Mexico that have legally been declared incapacitated.

## CC. Extraordinary Costs, Exceptions, and Other Matters Related to Compensation.

## **Campaign Contribution Disclosure Form**

Pursuant to NMSA 1978, § 13-1-191.1 (2006), any person seeking to enter into a contract with any state agency or local public body for professional services, a design and build project delivery system, or the design and installation of measures the primary purpose of which is to conserve natural resources must file this form with that state agency or local public body. This form must be filed even if the contract qualifies as a small purchase or a sole source contract. "Pendency of the procurement process" means the time period commencing with the public notice of the request for proposals and ending with the award of the contract or the cancellation of the request for proposals.

"Person" means any corporation, partnership, individual, joint venture, association or any other private legal entity.

"Prospective contractor" means a person who is subject to the competitive sealed proposal process set forth in the Procurement Code or is not required to submit a competitive sealed proposal because that person qualifies for a sole source or a small purchase contract.

"Representative of a prospective contractor" means an officer or director of a corporation, a member or manager of a limited liability corporation, a partner of a partnership or a trustee of a trust of the prospective contractor.

## **STATE OF NEW MEXICO**

#### **DEVELOPMENTAL DISABILITIES PLANNING COUNCIL (DDPC)** PROFESSIONAL SERVICES CONTRACT #\_\_\_\_\_

THIS AGREEMENT is made and entered into by and between the State of New Mexico, **DEVELOPMENTAL DISABILITIES PLANNING COUNCIL (DDPC)**, hereinafter referred to as the "Agency," and **NAME OF CONTRACTOR**, hereinafter referred to as the "Contractor," and is effective as of the date set forth below upon which it is executed by the General Services Department/State Purchasing Division (GSD/SPD Contracts Review Bureau).

#### IT IS AGREED BETWEEN THE PARTIES:

#### 1. <u>Scope of Work</u>.

The Contractor shall perform the following work:

**B.** <u>Services</u>. When assigned by Agency and appointed by a state district court, Contractor shall provide guardianship services to New Mexico residents who are at least eighteen (18) years old, qualify for Agency services, are financially eligible for Medicaid or a similar public benefit and have been adjudicated as incapacitated.

#### B. <u>Definitions</u>:

- (1) "Alleged Incapacitated Person" means an adult New Mexican alleged to be incapacitated who is financially eligible for Office of Guardianship legal services;
- (2) "Contractor" means the entity or individual contracting with Agency to provide guardianship services pursuant to this Agreement. Contractor shall be the "guardian of last resort" where no family member or other qualified person is willing, suitable or able to serve as guardian of the Protected Person;
- (3) "Court Visitor" means a person who is an appointee of a State district court who has no personal interest in the proceeding and who has been trained or has the expertise to appropriately evaluate the needs of the Alleged Incapacitated Person. A Court Visitor may include, but is not limited to, a psychologist, social worker, developmental incapacity professional, physical or occupational therapist, an educator and a rehabilitation worker (NMSA 1978, § 45-5-101(V));
- (4) "Agent" means an entity or individual whom the Executive Director has approved to represent or act on behalf of the Agency;
- (5) "GAL" means guardian ad litem: The attorney appointed by a State district court to represent and protect the interests of an Alleged Incapacitated Person in connection with an adult guardianship court proceeding (NMSA 1978, § 45-1-201(A)(22));
- (6) "Guardianship Coordinator" means the individual who has passed the Center for Guardianship Certification exam, is currently certified to work with Protected Persons, and serves the Protected Person as an employee or independent contractor of Contractor. If Contractor does not employ or contract with individual

Guardianship Coordinators, then "Contractor" and "Guardianship Coordinator" are one and the same.

- (7) "Office of Guardianship" means Agency's statutory program that contracts for the provision of probate code guardianship services to income-eligible adult New Mexicans needing a guardian;
- (8) "PET" means petitioning attorney: The attorney who petitions a State District Court for appointment of a guardian for an Alleged Incapacitated Person;
- (9) "Proposed Guardian" means the entity or individual assigned by the Office of Guardianship to provide a Protected Person with guardianship services as described by this Agreement; and
- (10) "Protected Person" means an adult New Mexican for whom a guardian has been appointed by a State district court in legal proceedings.

**C.** <u>Least Restrictive Standards</u>. Consistent with the court order appointing Contractor as Guardian, and adhering to the least restrictive standards of service, Contractor is responsible for decision-making in Protected Person's major life areas as authorized by the court order.

**D.** <u>**Guardianship Practices.**</u> Guardianship services shall be provided in accordance with the terms of this Agreement and the following legal authority and guardianship practices, including but not limited to the:

- (1) Uniform Probate Code (NMSA 1978, §§ 45-5-101 to -315);
- (2) Office of Guardianship Act (NMSA 1978, §§ 28-16B-1 to -6);
- (3) Uniform Health-Care Decisions Act (NMSA 1978, §§ 24-7A-1 to -18);
- (4) Mental Health Care Treatment Decisions Act (NMSA 1978, §§ 24-7B-1 to -6);
- (5) Adult Protective Services Act (NMSA 1978, §§ 27-7-1 to -31);
- (6) Rule of the Office of Guardianship (9.4.21 NMAC); and
- (7) National Guardianship Association (NGA): Standards of Practice; Ethical Principles for Guardians; and Standards for Agencies and Programs Providing Guardianship Services.

## E. <u>Certification and Criminal History Screening Requirements</u>.

- (1) Before contracting with Agency, Contractor shall successfully obtain certification through the Center for Guardianship Certification (CGC) or shall disclose non-certification to Agency. Contractor is responsible for all costs associated with CGC certification.
- (2) Contractor shall employ or contract with Guardianship Coordinators who possess certification through the CGC. Contractor shall ensure that each of their Guardianship Coordinators is certified within ninety (90) calendar days of being assigned the duties of guardian. Contractor shall provide Agency with copies of CGC certification for all such employees and contractors within thirty (30) calendar days of their certification.
- (3) Within ten (10) calendar days after hiring or contracting with a Guardianship Coordinator, Contractor shall provide Agency with: (a) the employee or contractor's name and date of hire or contract, and (b) a color photograph of and contact information (including telephone number and email address) for each

Guardianship Coordinator. Contractor shall update such contact information within five (5) business days of learning of the change. Agency shall have full authority to communicate with any Guardianship Coordinator regarding Contractor and Contractor's Protected Persons.

- (4) Contractor shall not allow non-CGC certified staff to make any decisions on behalf of a Protected Person. Contractor shall only assign Protected Person cases to certified Guardianship Coordinators.
- (5) Contractor and its Guardianship Coordinators shall maintain their CGC certifications throughout the term of this Agreement. Contractor shall immediately notify Agency if any CGC certification lapses, and shall re-obtain certification within thirty (30) calendar days. A Contractor or Guardianship Coordinator who has allowed its CGC certification to lapse shall not provide direct guardianship services to any Protected Persons served pursuant to this Agreement. Contractor shall be responsible for all fees and costs associated with any guardianship transfers made necessary by a lapse in CGC certification.
- (6) Contractor and its Guardianship Coordinators shall comply with the Caregivers Criminal History Screening Act (NMSA 1978, § 29-17-5) and Screening Requirements (7.1.9 NMAC). No Guardianship Coordinator shall perform any direct guardianship services under this Agreement until they have received a Notification of Clearance from the New Mexico Department of Health that specifically names Contractor as the facility that referred the applicant. Contractor shall provide Agency with the Notification of Clearance for each Guardianship Coordinator within five (5) calendar days of receipt. Contractor shall not employ or contract with any person who has been excluded from the Medicare or Medicaid Programs.
- (7) If Contractor fails to comply with any of the terms of this Paragraph, Agency may terminate the Agreement and, at Contractor's sole expense, transfer its appointed guardianships to other qualified guardians.

**F.** <u>Caseload</u>. Only certified Guardianship Coordinators shall carry a case load. Guardianship Coordinators shall not carry a caseload of more than thirty (30) Protected Persons. In rare circumstances, Agency may agree to an exception for an increased caseload.

## G. <u>Partnership with Protected Person</u>. Contractor shall ensure that:

- (1) A Protected Person receiving services is, to the highest degree possible, involved in individual planning, decision-making, implementation and evaluation of those services; and
- (2) All services provided are designed to enhance, promote and expand independence, self-sufficiency, self-esteem and quality of life of a Protected Person.
- (3) The Guardianship Coordinator shall have at least one in-person, individual face-toface visit per month with each Protected Person.

**H.** <u>Protected Person's Civil Rights</u>. A Protected Person for whom guardian has been appointed retains all legal and civil rights except those that have been expressly limited by court order.

Contractor shall notify Protected Person annually of their civil rights in a language and communication style that they best understand. The Protected Person, or someone, other than the Contractor or Guardian Coordinator, who knows them well, must acknowledge in writing annually that the Contractor reviewed the Protected Person's civil rights with them.

Contractor shall ensure that these rights are protected. These rights include, but are not limited to, the following:

- (1) The right to be free from unlawful discrimination, including age, disability, ethnicity, gender, marital status, national origin, race, religion, and sexual orientation;
- (2) The right to be treated humanely, with dignity and respect, and be protected against emotional or psychological abuse, physical abuse, sexual abuse, neglect and exploitation;
- (3) The right to be served in the most integrated setting appropriate to Protected Person's needs;
- (4) The right to practice the religion of their choice, or abstain from the practice of religion;
- (5) The right to receive visitors and communicate with others;
- (6) The right to privacy;
- (7) The right to participate in the political process, including the right to vote in accordance with NMSA 1978, § 45-5-109;
- (8) The right to voice grievances and complaints without interference, coercion, or reprisal;
- (9) The right to counsel and access to available advocacy services;
- (10) The right to have access to the courts;
- (11) The right to receive services to which they are entitled;
- (12) The right to be restored to capacity at the earliest possible time;
- (13) The right to have review of the need for restriction of rights;
- (14) The right to have a qualified guardian;
- (15) The right to remain as independent as possible;
- (16) The right to determine their place of residency, or have their preference honored;
- (17) The right to own, use, and control their property, or have their property managed prudently and have timely information about how their property is being managed;
- (18) The right to consent to or refuse medical treatment, unless that authority has been granted to a guardian, or if a treatment guardian has been appointed to make mental health treatment decisions pursuant to the Mental Health and Developmental Disabilities Code (NMSA 1978, § 43-1-15);
- (19) The right to seek or retain employment;
- (20) The right to travel; and
- (21) The right to notice and to attend all proceedings relating to their capacity.

I. <u>Person-Centered Plan</u>. Contractor shall prepare and maintain a plan consistent with NGA standards. When applicable, Contractor shall participate in, and coordinate with, Protected Person's Individual Service Plan or Interdisciplinary Team, consistent with NGA Standards of Practice. The Contractor's case file for the Protected Person shall contain a

person-centered plan developed in conjunction with the Protected Person, their guardian, and their service provider(s), if any. The plan shall reflect the goals and preferences of the Protected Person and shall address all of their needs, including medical and psychiatric care, residential needs, financial issues, and other needs specific to each Protected Person. The plan shall be updated at least annually.

J. <u>Case File Management</u>. Contractor shall maintain current, complete and comprehensive case files on each Protected Person that contain only those items pertaining to the services provided. All Protected Person's paper case files shall be segregated in a locked cabinet or locked file room and securely stored so as to protect the privacy of the Protected Person and deny access by unauthorized persons. All digital files pertaining to a Protected Person shall be secured so as to protect the privacy of the Protected Person shall be secured so as to protect the privacy of the Protected Person shall be secured as a required item is not applicable or unable to be obtained, written reasons shall be prepared and placed in Protected Person's file. The case file shall contain a table of contents listing each required item.

Each Protected Person's case file shall include all the specific information and documents set forth in National Guardianship Association (NGA) Standard of Practice 13.III.A - M (*Client file*), and the following additional information and documents:

- (1) Current background information form or coversheet for Protected Person that includes the Protected Person's name, date of birth, address, telephone number, Social Security number, medical coverage, health care providers, diagnoses, medications and allergies to medications, assigned Guardianship Coordinator and contact information, type of residence, and their contact information, two names and addresses of next of kin, if available;
- (2) Protected Person's birth certificate and Social Security card;
- (3) Sign-in sheet showing the name and date of anyone other than the Contractor's staff that has accessed the file;
- (4) Financial eligibility information, including as applicable, current income, Medicaid eligibility and trusts;
- (5) Contractor's internal complaint procedures form reviewed and signed annually by the Protected Person or someone who knows them well, which cannot be the Contractor or Guardianship Coordinator;
- (6) All documents relating to reports of incidents and records of all incident investigations against the Contractor, their Guardian Coordinator, or involving their Protected Person, including findings and outcomes;
- (7) Correspondence relating to Protected Person;
- (8) All court-endorsed pleadings, orders, and annual reports; and
- (9) Quarterly financial statements of the Protected Person when Contractor has financial authority granted in their guardianship order.

## K. Finances of the Protected Person and Financial Ledgers.

(6) In every case where Contractor has financial authority of a Protected Person in their guardianship order, Contractor shall monitor the Protected Person's finances for exploitation, misuse, and fraud. Contractor shall develop and maintain written internal policies and procedures governing how the Contractor manages or monitors a Protected Person's funds. Contractor shall ensure all staff are trained on these policies and procedures;

- (7) Contractors with financial authority in their guardianship order must maintain quarterly financial statements regarding the Protected Person. For Contractors with financial authority but the Social Security Administration has appointed a Representative Payee other than Contractor, quarterly financial statements generated by the Representative Payee are required in each file. If Contractor is unable to obtain quarterly financial statements from a Representative Payee, Contractor shall document their attempts and report the Representative Payee's lack of cooperation to the Social Security Administration.
- (8) Contractor shall maintain separate financial accounts and detailed ledgers for each Protected Person for whom the Contractor or Guardianship Coordinator makes any financial decision or transaction;
- (9) Contractor shall maintain and monitor quarterly financial reports showing the beginning balance of each Protected Person's financial account, line items for incoming revenue and outgoing expenses, and an ending balance;
- (10) Contractor shall submit to Agency all requested financial reports within three (3) business days of Agency making such request.

## L. Contractor's Records.

- (1) Contractor shall maintain detailed records of each Protected Person's visit, specifying the date, amount of time (in quarter hour increments), nature of all services rendered, and identification of the person(s) providing the services. Documentation shall include signature of the Guardian Coordinator and the Protected Person or someone, other than the Contractor or Guardian Coordinator, who knows them well Contractor shall maintain these records for a period of seven (7) years from the date of final payment under this Agreement.
- (2) All billing and case file records shall be subject to immediate inspection and copying by Agency or its agents, the Department of Finance and Administration (DFA), and the State Auditor. Agency shall have the right to audit all billings and monthly reports both before, and for seven (7) years after payment is made. Payment pursuant to this Agreement shall not foreclose Agency's right to recover any excessive, illegal, or improper payments made to Contractor.

M. <u>Complaint Procedures</u>. Contractor shall establish and implement internal written procedures available to all Protected Persons to present complaints relating to Contractor's services. Complaint procedures shall comply with the rules of the Office of Guardianship, 9.4.21.14 NMAC, *Complaints Against Contractors* and shall include, at a minimum, the following:

- (2) Contractor shall notify Protected Person of the complaint procedures annually in a language and communication style that they best understand. The Protected Person or their representative must acknowledge that the Contractor reviewed its internal written complaint procedures;
- (2) Within thirty (30) calendar days after receipt of the complaint, Contractor shall:
  - (a) Meet in person with Protected Person and, if applicable, their representative, and attempt to reach a written resolution;
  - (b) Document in writing the resolution or non-resolution of the complaint, signed and dated by all parties to the attempted resolution;

- (c) Explain the complaint resolution to Protected Person and document this explanation, including date, time, and person communicating with Protected Person; and
- (d) Provide the written complaint resolution to Protected Person and, if applicable, their representative, and maintain a copy in Protected Person's case file.
- (3) Contractor shall forward to Agency either the:
  - (a) Written complaint resolution within five (5) business days, or
  - (b) Unresolved complaint within two (2) business days after the thirty (30) day deadline for complaint resolution; and

(4) If the complaint cannot be resolved with Contractor, Protected Person or their representative may submit the written complaint to the Office of Guardianship, with a copy given to Contractor.

**N.** <u>Incident Reporting</u>. Within five (5) business days of learning of an allegation, Contractor shall provide Agency, in writing, the following information regarding any allegations of abuse, neglect, or exploitation made against Contractor in regard to a Protected Person:

- (1) When received by Contractor, copies of all documents received from Department of Health's Division of Health Improvement (DHI) and Aging and Long-Term Services Department's Adult Protective Services (APS); and
- (2) Copies of all complaints, reports, and correspondence made to DHI Licensing and Certification, APS, or Attorney General's Medicaid Fraud and Elder Abuse Division involving the Protected Person.

**O.** <u>Insurance</u>. Contractors with a contract of \$60,000 or less in compensation shall obtain and maintain professional liability insurance in an amount no less than \$500,000 per occurrence and \$1 million in the aggregate. Contractors with a contract over \$60,000 in compensation shall obtain and maintain professional liability insurance in an amount no less than \$1 million per occurrence and \$3 million in the aggregate. Insurance shall cover acts of misconduct, violations of fiduciary duties, and civil and criminal misconduct by Contractor, its Guardianship Coordinators, and its employees and subcontractors. Insurance shall be obtained through a company licensed to do business in New Mexico and in good standing. The State of New Mexico Developmental Disabilities Planning Council shall be identified as an Additional Insured. Contractor shall disclose, in writing, proof of professional liability insurance coverage and the amount of coverage within thirty (30) days after the effective date of this Agreement. The policy shall require that Agency is immediately notified by the insurance company, in writing, if insurance coverage lapses or is terminated.

**P.** <u>Fidelity/Dishonesty Bond</u>. Contractor shall obtain and maintain a fidelity or dishonesty bond covering each person who administers or authorizes payment of Protected Person funds or those monies received pursuant to this Agreement. Contractor shall disclose, in writing, proof and the amount of this fidelity or dishonesty bond within thirty (30) days after the effective date of this Agreement. The policy shall require that Agency is immediately notified by the insurance company, in writing, if insurance coverage lapses or is terminated.

 The fidelity bond shall provide for indemnification of losses occasioned by (a) any fraudulent or dishonest act or acts committed by any of Contractor's employees or agents acting alone or in collusion, and (b) the failure of Contractor or its employees or agents to perform faithfully any duty or properly account for all monies and property received or entrusted by Contractor.

- (2) If the total amount of this Agreement is less than One Hundred Thousand Dollars (\$100,000) per year, the minimum fidelity bond shall be Ten Thousand Dollars (\$10,000). If the total Agreement amount is more than One Hundred Thousand Dollars (\$100,000) per year, the fidelity bond shall be in an amount equal to twenty-five percent (25%) of the total Agreement amount. The fidelity bond shall remain in effect for the term of this Agreement plus thirty (30) days.
- (3) The fidelity bond shall include third-party coverage for the property of Protected Persons. In the event Contractor cannot obtain a third-party fidelity bond, Agency reserves the right to require a financial guarantee surety bond naming Agency as Obligee and in an amount to be determined. Agency may waive either of these bond requirements. If Contractor is a sole proprietorship or partnership, the proprietor or partners shall be considered employees or agents under the terms of the fidelity bond. The State of New Mexico Developmental Disabilities Planning Council shall be named as Loss Payee.

**Q.** <u>Notice of Death, Serious Injury or Elopement</u>. Contractor shall provide written notice to Agency of the following actions, as specifically prescribed below, and, as applicable, shall immediately provide Agency with copies of all filed and/or endorsed documents:

- (1) Within seventy-two (72) hours after learning of the death of a Protected Person. Within thirty (30) calendar days after the death, Contractor shall provide Agency a copy of the court-endorsed Final Report of Guardian;
- (2) Within twenty-four (24) hours after learning of any life-threatening or serious injury sustained by a Protected Person;
- (3) Within seventy-two (72) hours after learning of a Protected Person missing or eloping from their residence. Contractor shall also (a) file a missing person's report with a law enforcement agency in the Protected Person's last known county of residence, and (b) file a Notice of Elopement with the court.

## **R.** <u>Notice of Changes</u>. Contractor shall immediately notify Agency in writing:

- (1) Of any change in Protected Person's contact information;
- (2) Of any change in Contractor's contact information;
- (3) Of any change in the level of assets or resources that may make Protected Person ineligible for Medicaid or a similar public benefit, and thus ineligible for State-funded guardianship services, within thirty (30) calendar days after Contractor receives such information;
- (4) If it learns that another person may be willing, suitable and able to serve as the guardian of Protected Person, so that Agency may determine if a transfer of guardianship is appropriate; and
- (5) If Protected Person appears to have made gains in their capacity or be in need of increased protection such that a court's review of the guardianship is indicated. Contractor shall then act in accordance with 9.4.21.18 NMAC, *Comprehensive Evaluations*.

**S.** <u>Resignation and Termination as Guardian; Transfer to Successor Guardian</u>. To ensure continuity of care for Protected Persons served pursuant to this Agreement.

- (1) If Contractor wishes to resign or terminate serving as a court-appointed guardian for Protected Person (for any reason other than Protected Person's death), Contractor shall provide advance written notice to Agency of its desire to resign at least 90 days prior to resignation and provide detailed reasons for so doing.
- (2) If Contractor wishes to transfer guardianship of Protected Person to a successor guardian, Contractor shall provide at least thirty (30) days advance written notice to Agency of its desire to transfer, and provide detailed reasons for so doing. Unless Agency determines good cause exists to transfer guardianship, Contractor is liable for the legal expenses necessary to transfer the guardianship.
- (3) Contractor shall comply with all Agency requirements regarding transfers and reassignments.
- (4) For any resignation, termination, or transfer of guardianship proceeding, Contractor shall name Agency as an Interested Person and provide notice to Agency of all legal proceedings, including court hearings and status conferences.
- (5) If appropriate, Agency shall assign a successor guardian and shall make reasonable efforts to have a successor guardian appointed by the court. Contractor shall **not** itself arrange for a particular person to be appointed as successor guardian.
- (6) Contractor shall continue to serve as the court-appointed guardian until the court orders otherwise or appoints a successor guardian.

**T.** <u>Audits</u>. The Agency may utilize outside contractors, including certified public accountants, to audit Contractor's (1) billings related to Medicaid; (2) services funded pursuant to this Agreement; and (3) management of the Protected Person's financial affairs, if applicable. Agency shall provide Contractor at least two (2) weeks advance written notice of such an audit. Contractor shall cooperate fully with Agency and outside contractors acting as agents of the Agency.

## U. Access to Records.

- (1) Agency shall have access to the Protected Person's case records, including but not limited to: copies of court filings and reports, financial records, and all other records maintained by the Contractor related to contracted services provided and the scope of the court orders, unless specifically sequestered by the courts.
- (2) When requested, or during Agency's visit with Protected Person, Contractor shall immediately produce all records and files of Protected Person.
  - (a) If Contractor cannot produce the records immediately, it shall produce those records on or before the close of business the day after the request.
  - (b) Contractor's failure or refusal, without good cause shown, to timely produce the records shall constitute a breach of this Agreement and Agency may deny payment to Contractor for that Protected Person for the month(s) the records are not timely produced.
- (3) When transferring guardianship to a successor guardian, Contractor shall transmit the contents of the original Protected Person's case file and an inventory list of personal property of Protected Person to the successor guardian at the court hearing on the transfer.
  - (a) If the transfer is ordered without a hearing, Contractor shall transmit this client case file and the Protected Person's personal property to the successor guardian within twenty-four (24) hours after entry of a court order.

(b) Contractor's failure or refusal, without good cause shown, to timely transfer the complete client case file shall constitute a breach of this Agreement and Agency may impose any sanction it deems appropriate and may deny payment to Contractor for that Protected Person for the month(s) the records are not timely transferred.

V. <u>Monitoring Review</u>. Agency may periodically conduct reviews to ensure the delivery of quality services consistent with this Agreement. Contractor shall fully comply with the requirements of any services review of an account, inventory, or property of the Protected Person. This services review includes, but is not limited to, an examination of the following:

- (1) Protected Persons are living in conditions that are least restrictive, promote independence and autonomy, and are appropriate to their needs;
- (2) Contractor establishes and implements an adequate internal complaint procedure, available to all Protected Persons;
- (3) Protected Person's civil and legal rights are adequately safeguarded;
- (4) Staff is qualified by education, training, and experience to perform the duties of guardian;
- (5) Contractor adopts and implements policies and procedures that are consistent with the NGA Standards of Practice, NGA Ethical Principles for Guardians, and NGA Standards for Agencies and Programs Providing Guardianship Services;
- (6) Contractor complies with all terms and conditions of this Agreement;
- (7) Contractor maintains insurance and bonding requirements;
- (8) Contractor maintains all billing and accounting records related to the Protected Person;
- (9) Termination of Protected Person's services is appropriate under the circumstances;
- (10) All Guardianship Coordinators shall be available for any Agency onsite visit or comprehensive services review;
- (11) All court-endorsed pleadings and reports; and
- (12) Services in accordance with this Agreement and within in the scope of the order granted by the courts.

W. <u>Mandatory Annual Contractors Meeting</u>. There shall be an annual Contractors meeting that Contractors must attend. Contractor and its Guardianship Coordinators must know and comply with all information presented at this meeting. Agency will notify Contractor at least sixty (60) days in advance of the meeting date, time and location.

## X. <u>Corrective Action Plan/Sanctions.</u>

If Agency determines that Contractor failed to comply with any terms of this Agreement, statutory obligation, or court order, or fails to timely address a Protected Person's needs or grievances, Agency may provide Contractor with a *Written Notification of Deficiencies* and may require Contractor to develop and submit to Agency a proposed *Corrective Action Plan (CAP)* that timely addresses and resolves these deficiencies.

If required by Agency, Contractor shall develop and submit to Agency a proposed *CAP* within thirty (30) business days after receipt of the *Written Notification of Deficiencies*. If necessary, Contractor may request additional time to submit their proposed *CAP*, but Agency reserves the right to decline an extension.

The *CAP* shall include, at a minimum:

- (a) Identification of the deficiencies;
- (b) Specific corrective action steps Contractor shall take to resolve the deficiencies;
- (c) Timeframe necessary to complete each corrective action step;
- (d) Anticipated date of completion of *CAP*; and
- (e) Names of the persons responsible for each corrective action step.

Agency shall provide Contractor a written acceptance or rejection of the proposed *CAP* within fifteen (15) business days of receiving the proposed *CAP* from Contractor.

When all identified deficiencies are resolved to the Agency's satisfaction, Agency shall provide Contractor with a Statement of Compliance.

If Contractor cannot resolve the identified deficiencies to Agency's satisfaction within 120 days after the date of the Agency-approved *CAP*, Agency has the right to:

- (c) Take such other actions as it deems appropriate
- (d) Withhold payment from Contractor
  - a. Thirty (30) days after Contractor's receipt of the *Written Notification of Deficiencies*, Agency shall withhold from Contractor's total monthly contract payment: (a) 15% of Contractor's total monthly contractual payment for the first month of noncompliance, and (b) 20% for the second month of noncompliance.
  - b. Agency's withholding of payment for any given month shall remain in effect even if Contractor comes into compliance during that month.
  - c. Upon Agency's written *Statement of Compliance*, Agency shall resume contract payments.
- (g) Seek damages and attorney fees from Contractor for transferring guardianship to another guardian;
- (h) Seek reimbursement from Contractor for Agency costs incurred as a result of contract non-compliance;
- (i) File a claim with Contractor's insurance and bond providers;
- (j) Terminate this Agreement; and
- (g) Seek further redress through State and Federal law.

**Y.** <u>Conflict of Interest</u>. No Contractor shall serve on the board of directors of another service provider contracted by Agency. No state employee whose job functions have a direct impact on the Office of Guardianship shall serve on Contractor's board of directors. Contractor shall avoid serving on an assigned guardianship case if their spouse, significant other, immediate family member, business partner or employer is also assigned to the same case.

**Z.** <u>Prompt Communication</u>. Contractor shall, without exception or excuse, respond to any and all Office of Guardianship and PET communications within forty-eight (48) hours.

**AA.** <u>Invoicing</u>. Contractor shall invoice for services provided to eligible Protected Persons who have received court-appointed guardianship services through the Office of Guardianship.

Contractor shall submit invoices to Agency's Contract Specialist by the 5<sup>th</sup> day of the month for the previous billing month's services. Invoices received after this date may have payment delayed.

All invoices must be approved by Agency. Agency shall process approved invoices for payment and submit to DFA for approval, so long as Contractor is in compliance with all terms and requirements of this Agreement.

In order to receive payment, each monthly face-to-face visit must be documented by the dated signatures of both the Guardianship Coordinator and the Protected Person or someone who knows them well, other than Contractor or the Guardian Coordinator.

Contractor shall obtain written assignment as guardian from Agency in order to invoice and be paid by Agency for guardianship services:

- (1) If Adult Protective Services or a court requests Contractor to serve as guardian, before Contractor accepts such appointment, Contractor must request and receive written assignment from Agency in order to be paid by Agency.
- (2) Contractor may select a Guardianship Coordinator to serve Protected Person, but shall consider Agency's criteria and the best interests of Protected Person (e.g., Protected Person needs a guardian of a specific gender or background).
- (3) Agency has the sole discretion to determine assignments.

**BB.** <u>Medicaid Reporting</u>. A Contractor with fifteen (15) or more Protected Persons receiving Medicaid benefits shall participate in Medicaid reporting to Agency, in compliance with requests and guidelines set forth by Agency. Contractors with fewer than fifteen (15) Protected Persons may participate in time-reporting and Medicaid reimbursement. Any mandated or optional participant in Medicaid Reporting is referred to as "Participating Contractor."

- (1) Upon Agency's receipt of supplementary funding from Centers for Medicare and Medicaid Services (CMS), Agency shall reimburse Participating Contractor only if that Contractor provides Agency with all information and requested documents by Agency deadlines.
- (2) Participating Contractor shall receive reimbursement of four percent (4%) of Contractor's allowable amount billed to CMS.
- (3) All Guardianship Coordinators of Participating Contractor shall complete "Daily Time Allocation Worksheets" (Worksheets) for dates identified by Agency, indicating in fifteen (15) minute increments (units of service), the time spent each weekday on both Medicaid-related and non-Medicaid-related activities, totaling thirty-six (36) units of service.
- (4) Participating Contractor shall submit to Agency: Worksheets, Random Samples and other requested documents by Agency deadlines. A Worksheet shall include the following:
  - (i) Participating Contractor name as used in this Agreement;
  - (ii) Guardianship Coordinator name;
  - (iii) First initial and last name of each Protected Person served;
  - (iv) Units of service reported by Category I (Contact), II (Medical), III (Care Plan), IV (Travel) or V (Other, Non-Allowable);

- (v) Each unit of service must include a brief description of services reported under Categories I-IV;
- (vi) Each worksheet must equal thirty-six (36) units of service; and
- (vii) The Guardianship Coordinator's written affirmation as to the Worksheet's accuracy, and signed and dated.
- (5) Agency will generate a Consolidated Data Sheet and provide it to Participating Contractor for its review. Participating Contractor shall attest to the accuracy of the Consolidated Data Sheet by its signature, title, telephone number and date signed, in blue ink.
- (6) Agency will provide technical assistance and consultation, as needed, to Participating Contractor on the requirements for its participation in the reporting and administrative claiming of guardianship services for recipients of New Mexico that have legally been declared incapacitated.

#### CC. Extraordinary Costs, Exceptions, and Other Matters Related to Compensation.

- (1) Requests for reimbursement of extraordinary costs and exceptions must be approved in advance by Agency Executive Director or designee. Agency may reimburse Contractor, subject to available resources, the current DFA-approved rates for mileage (calculated from www.randmcnally.com, www.nmroads.com, or actual mileage from odometer reading) and per diem (\$85 per 24-hour period) only when Contractor travels an excessive distance in performance of duties pursuant to this Agreement. This is intended to cover non-routine situations, and is reserved for extraordinary situations or exceptions requiring extensive cost by the guardian to protect the health and safety of the Protected Person. If Agency Executive Director or designee approves payment in advance for extraordinary costs, Contractor shall invoice these prior-approved extraordinary costs as described in Paragraph AA, *Invoicing*.
- (2) Contractor may submit in writing to Agency a request for approval of exception(s) for unanticipated circumstance or extraordinary costs.
- (3) Agency may offer Contractor additional funding or resources for extraordinary circumstances the Agency deems an exception.
- (4) After the death of a Protected Person, Contractor may invoice for the month of death and one (1) month thereafter, and shall specifically note this on the invoice.

# 2. <u>Compensation.</u>

A. The Agency shall pay to the Contractor in full payment for services satisfactorily performed at the rate of \$325.00 per Protected Person, per month, such compensation not to exceed \$325. The total amount payable to the Contractor under this Agreement, including gross receipts tax and expenses, shall not exceed \$385. This amount is a maximum and not a guarantee that the work assigned to be performed by Contractor under this Agreement shall equal the amount stated herein. The parties do not intend for the Contractor to continue to provide services without compensation when the total compensation amount is reached. Contractor is responsible for notifying the Agency when the services provided under this Agreement reach the total compensation amount. In no event will the Contractor be paid for services provided

# in excess of the total compensation amount without this Agreement being amended in writing prior to those services in excess of the total compensation amount being provided.

**B.** Payment is subject to availability of funds pursuant to the Appropriations Paragraph set forth below and to any negotiations between the parties from year to year pursuant to Paragraph 1, Scope of Work, and to approval by the DFA. All invoices MUST BE received by the Agency no later than fifteen (15) days after the termination of the Fiscal Year in which the services were delivered. Invoices received after such date WILL NOT BE PAID.

**C.** Contractor must submit a detailed statement accounting for all services performed and expenses incurred. If the Agency finds that the services are not acceptable, within thirty days after the date of receipt of written notice from the Contractor that payment is requested, it shall provide the Contractor a letter of exception explaining the defect or objection to the services, and outlining steps the Contractor may take to provide remedial action. Upon certification by the Agency that the services have been received and accepted, payment shall be tendered to the Contractor within thirty days after the date of acceptance. If payment is made by mail, the payment shall be deemed tendered on the date it is postmarked. However, the agency shall not incur late charges, interest, or penalties for failure to make payment within the time specified herein.

# 3. <u>Term.</u>

THIS AGREEMENT SHALL NOT BECOME EFFECTIVE UNTIL APPROVED BY THE GSD/SPD Contracts Review Bureau. This Agreement shall terminate on (**DATE**) unless terminated pursuant to paragraph 4 (Termination), or paragraph 5 (Appropriations). In accordance with NMSA 1978, § 13-1-150, no contract term for a professional services contract, including extensions and renewals, shall exceed four years, except as set forth in NMSA 1978, § 13-1-150.

# 4. <u>Termination.</u>

A. <u>Grounds</u>. The Agency may terminate this Agreement for convenience or cause. The Contractor may only terminate this Agreement based upon the Agency's uncured, material breach of this Agreement.

B. <u>Notice; Agency Opportunity to Cure.</u>

1. Except as otherwise provided in Paragraph (4)(B)(3), the Agency shall give Contractor written notice of termination at least thirty (30) days prior to the intended date of termination.

2. Contractor shall give Agency written notice of termination at least thirty (30) days prior to the intended date of termination, which notice shall (i) identify all the Agency's material breaches of this Agreement upon which the termination is based and (ii) state what the Agency must do to cure such material breaches. Contractor's notice of termination shall only be effective (i) if the Agency does not cure all material breaches within the thirty (30) day notice period or (ii) in the case of material breaches that cannot be cured within thirty (30) days, the Agency does not, within the thirty (30) day notice period, notify the Contractor of its intent to cure and begin with due diligence to cure the material breach.

3. Notwithstanding the foregoing, this Agreement may be terminated immediately upon written notice to the Contractor (i) if the Contractor becomes unable to perform the services

contracted for, as determined by the Agency; (ii) if, during the term of this Agreement, the Contractor is suspended or debarred by the State Purchasing Agent; or (iii) the Agreement is terminated pursuant to Paragraph 5, "Appropriations", of this Agreement.

C. <u>Liability.</u> Except as otherwise expressly allowed or provided under this Agreement, the Agency's sole liability upon termination shall be to pay for acceptable work performed prior to the Contractor's receipt or issuance of a notice of termination; <u>provided</u>, <u>however</u>, that a notice of termination shall not nullify or otherwise affect either party's liability for pre-termination defaults under or breaches of this Agreement. The Contractor shall submit an invoice for such work within thirty (30) days of receiving or sending the notice of termination. <u>THIS PROVISION IS NOT EXCLUSIVE AND DOES NOT WAIVE THE AGENCY'S OTHER LEGAL RIGHTS AND REMEDIES CAUSED BY THE CONTRACTOR'S DEFAULT/BREACH OF THIS AGREEMENT.</u>

D. <u>Termination Management</u>. Immediately upon receipt by either the Agency or the Contractor of notice of termination of this Agreement, the Contractor shall: 1) not incur any further obligations for salaries, services or any other expenditure of funds under this Agreement without written approval of the Agency; 2) comply with all directives issued by the Agency in the notice of termination as to the performance of work under this Agreement; and 3) take such action as the Agency shall direct for the protection, preservation, retention or transfer of all property titled to the Agency and records generated under this Agreement. Any non-expendable personal property or equipment provided to or purchased by the Contractor with contract funds shall become property of the Agency upon termination and shall be submitted to the agency as soon as practicable.

# 5. <u>Appropriations.</u>

The terms of this Agreement are contingent upon sufficient appropriations and authorization being made by the Legislature of New Mexico for the performance of this Agreement. If sufficient appropriations and authorization are not made by the Legislature, this Agreement shall terminate immediately upon written notice being given by the Agency to the Contractor. The Agency's decision as to whether sufficient appropriations are available shall be accepted by the Contractor and shall be final. If the Agency proposes an amendment to the Agreement to unilaterally reduce funding, the Contractor shall have the option to terminate the Agreement or to agree to the reduced funding, within thirty (30) days of receipt of the proposed amendment.

# 6. <u>Status of Contractor.</u>

The Contractor and its agents and employees are independent contractors performing professional services for the Agency and are not employees of the State of New Mexico. The Contractor and its agents and employees shall not accrue leave, retirement, insurance, bonding, use of state vehicles, or any other benefits afforded to employees of the State of New Mexico as a result of this Agreement. The Contractor acknowledges that all sums received hereunder are reportable by the Contractor for tax purposes, including without limitation, self-employment and business income tax. The Contractor agrees not to purport to bind the State of New Mexico unless the Contractor has express written authority to do so, and then only within the strict limits of that authority.

# 7. <u>Assignment.</u>

The Contractor shall not assign or transfer any interest in this Agreement or assign any claims for money due or to become due under this Agreement without the prior written approval of the Agency.

#### 8. <u>Subcontracting.</u>

The Contractor shall not subcontract any portion of the services to be performed under this Agreement without the prior written approval of the Agency. No such subcontract shall relieve the primary Contractor from its obligations and liabilities under this Agreement, nor shall any subcontract obligate direct payment from the Procuring Agency.

#### 9. <u>Release.</u>

Final payment of the amounts due under this Agreement shall operate as a release of the Agency, its officers and employees, and the State of New Mexico from all liabilities, claims and obligations whatsoever arising from or under this Agreement.

#### 10. <u>Confidentiality.</u>

Any confidential information provided to or developed by the Contractor in the performance of this Agreement shall be kept confidential and shall not be made available to any individual or organization by the Contractor without the prior written approval of the Agency.

#### 11. <u>Product of Service -- Copyright.</u>

All materials developed or acquired by the Contractor under this Agreement shall become the property of the State of New Mexico and shall be delivered to the Agency no later than the termination date of this Agreement. Nothing developed or produced, in whole or in part, by the Contractor under this Agreement shall be the subject of an application for copyright or other claim of ownership by or on behalf of the Contractor.

#### 12. <u>Conflict of Interest; Governmental Conduct Act.</u>

A. The Contractor represents and warrants that it presently has no interest and, during the term of this Agreement, shall not acquire any interest, direct or indirect, which would conflict in any manner or degree with the performance or services required under the Agreement.

B. The Contractor further represents and warrants that it has complied with, and, during the term of this Agreement, will continue to comply with, and that this Agreement complies with all applicable provisions of the Governmental Conduct Act, Chapter 10, Article 16 NMSA 1978. Without in anyway limiting the generality of the foregoing, the Contractor specifically represents and warrants that:

1) in accordance with NMSA 1978, § 10-16-4.3, the Contractor does not employ, has not employed, and will not employ during the term of this Agreement any Agency employee while such employee was or is employed by the Agency and participating directly or indirectly in the Agency's contracting process;

2) this Agreement complies with NMSA 1978, § 10-16-7(A) because (i) the Contractor is not a public officer or employee of the State; (ii) the Contractor is not a member of the family of a public officer or employee of the State; (iii) the Contractor is not a business in which a public officer or employee or the family of a public officer or

employee has a substantial interest; or (iv) if the Contractor is a public officer or employee of the State, a member of the family of a public officer or employee of the State, or a business in which a public officer or employee of the State or the family of a public officer or employee of the State has a substantial interest, public notice was given as required by NMSA 1978, § 10-16-7(A) and this Agreement was awarded pursuant to a competitive process;

3) in accordance with NMSA 1978, § 10-16-8(A), (i) the Contractor is not, and has not been represented by, a person who has been a public officer or employee of the State within the preceding year and whose official act directly resulted in this Agreement and (ii) the Contractor is not, and has not been assisted in any way regarding this transaction by, a former public officer or employee of the State whose official act, while in State employment, directly resulted in the Agency's making this Agreement;

4) this Agreement complies with NMSA 1978, § 10-16-9(A)because (i) the Contractor is not a legislator; (ii) the Contractor is not a member of a legislator's family; (iii) the Contractor is not a business in which a legislator or a legislator's family has a substantial interest; or (iv) if the Contractor is a legislator, a member of a legislator's family, or a business in which a legislator or a legislator, a member of a legislator's family, or a business in which a legislator or a legislator's family has a substantial interest; disclosure has been made as required by NMSA 1978, § 10-16-7(A), this Agreement is not a sole source or small purchase contract, and this Agreement was awarded in accordance with the provisions of the Procurement Code;

5) in accordance with NMSA 1978, § 10-16-13, the Contractor has not directly participated in the preparation of specifications, qualifications or evaluation criteria for this Agreement or any procurement related to this Agreement; and

6) in accordance with NMSA 1978, § 10-16-3 and § 10-16-13.3, the Contractor has not contributed, and during the term of this Agreement shall not contribute, anything of value to a public officer or employee of the Agency.

C. Contractor's representations and warranties in Paragraphs A and B of this Article 12 are material representations of fact upon which the Agency relied when this Agreement was entered into by the parties. Contractor shall provide immediate written notice to the Agency if, at any time during the term of this Agreement, Contractor learns that Contractor's representations and warranties in Paragraphs A and B of this Article 12 were erroneous on the effective date of this Agreement or have become erroneous by reason of new or changed circumstances. If it is later determined that Contractor's representations and warranties in Paragraphs A and B of this Agreement or have become erroneous on the effective date of this Agreement or have become erroneous on the effective date of the Agreement or have become erroneous by reason of new or changed circumstances, in addition to other remedies available to the Agency and notwithstanding anything in the Agreement to the contrary, the Agency may immediately terminate the Agreement.

D. All terms defined in the Governmental Conduct Act have the same meaning in this Article 12(B).

# 13. <u>Amendment.</u>

A. This Agreement shall not be altered, changed or amended except by instrument in writing executed by the parties hereto and all other required signatories.

B. If the Agency proposes an amendment to the Agreement to unilaterally reduce funding due to budget or other considerations, the Contractor shall, within thirty (30) days of receipt of the proposed Amendment, have the option to terminate the Agreement, pursuant to the termination provisions as set forth in Article 4 herein, or to agree to the reduced funding.

# 14. Merger.

This Agreement incorporates all the Agreements, covenants and understandings between the parties hereto concerning the subject matter hereof, and all such covenants, Agreements and understandings have been merged into this written Agreement. No prior Agreement or understanding, oral or otherwise, of the parties or their agents shall be valid or enforceable unless embodied in this Agreement.

# 15. <u>Penalties for violation of law.</u>

The Procurement Code, NMSA 1978 §§ 13-1-28 through 13-1-199, imposes civil and criminal penalties for its violation. In addition, the New Mexico criminal statutes impose felony penalties for illegal bribes, gratuities and kickbacks.

# 16. Equal Opportunity Compliance.

The Contractor agrees to abide by all federal and state laws and rules and regulations, and executive orders of the Governor of the State of New Mexico, pertaining to equal employment opportunity. In accordance with all such laws of the State of New Mexico, the Contractor assures that no person in the United States shall, on the grounds of race, religion, color, national origin, ancestry, sex, age, physical or mental handicap, or serious medical condition, spousal affiliation, sexual orientation or gender identity, be excluded from employment with or participation in, be denied the benefits of, or be otherwise subjected to discrimination under any program or activity performed under this Agreement. If Contractor is found not to be in compliance with these requirements during the life of this Agreement, Contractor agrees to take appropriate steps to correct these deficiencies.

# 17. <u>Applicable Law.</u>

The laws of the State of New Mexico shall govern this Agreement, without giving effect to its choice of law provisions. Venue shall be proper only in a New Mexico court of competent jurisdiction in accordance with NMSA 1978, § 38-3-1 (G). By execution of this Agreement, Contractor acknowledges and agrees to the jurisdiction of the courts of the State of New Mexico over any and all lawsuits arising under or out of any term of this Agreement.

# 18. <u>Workers Compensation.</u>

The Contractor agrees to comply with state laws and rules applicable to workers compensation benefits for its employees. If the Contractor fails to comply with the Workers Compensation Act and applicable rules when required to do so, this Agreement may be terminated by the Agency.

# 19. <u>Records and Financial Audit.</u>

The Contractor shall maintain detailed time and expenditure records that indicate the date; time, nature and cost of services rendered during the Agreement's term and effect and retain them for a period of three (3) years from the date of final payment under this Agreement. The records

shall be subject to inspection by the Agency, the General Services Department/State Purchasing Division and the State Auditor. The Agency shall have the right to audit billings both before and after payment. Payment under this Agreement shall not foreclose the right of the Agency to recover excessive or illegal payments

# 20. <u>Indemnification.</u>

The Contractor shall defend, indemnify and hold harmless the Agency and the State of New Mexico from all actions, proceeding, claims, demands, costs, damages, attorneys' fees and all other liabilities and expenses of any kind from any source which may arise out of the performance of this Agreement, caused by the negligent act or failure to act of the Contractor, its officers, employees, servants, subcontractors or agents, or if caused by the actions of any client of the Contractor resulting in injury or damage to persons or property during the time when the Contractor or any officer, agent, employee, servant or subcontractor thereof has or is performing services pursuant to this Agreement. In the event that any action, suit or proceeding related to the services performed by the Contractor or any officer, agent, employee, servant or subcontractor shall, as soon as practicable but no later than two (2) days after it receives notice thereof, notify the legal counsel of the Agency and the Risk Management Division of the New Mexico General Services Department by certified mail.

# 21. <u>New Mexico Employees Health Coverage.</u>

A. If Contractor has, or grows to, six (6) or more employees who work, or who are expected to work, an average of at least 20 hours per week over a six (6) month period during the term of the contract, Contractor certifies, by signing this agreement, to have in place, and agree to maintain for the term of the contract, health insurance for those employees and offer that health insurance to those employees if the expected annual value in the aggregate of any and all contracts between Contractor and the State exceed \$250,000 dollars.

B. Contractor agrees to maintain a record of the number of employees who have (a) accepted health insurance; (b) declined health insurance due to other health insurance coverage already in place; or (c) declined health insurance for other reasons. These records are subject to review and audit by a representative of the state.

C. Contractor agrees to advise all employees of the availability of State publicly financed health care coverage.

# 22. Invalid Term or Condition.

If any term or condition of this Agreement shall be held invalid or unenforceable, the remainder of this Agreement shall not be affected and shall be valid and enforceable.

# 23. Enforcement of Agreement.

A party's failure to require strict performance of any provision of this Agreement shall not waive or diminish that party's right thereafter to demand strict compliance with that or any other provision. No waiver by a party of any of its rights under this Agreement shall be effective unless

express and in writing, and no effective waiver by a party of any of its rights shall be effective to waive any other rights.

# 24. <u>Notices.</u>

Any notice required to be given to either party by this Agreement shall be in writing and shall be delivered in person; by courier service; by postage prepaid U.S. mail, either first class or certified, return receipt requested; by email; or by fax, as follows:
